Community Support Services and the Corporation for Supportive Housing Host Keeping Families Together Leadership Forum

Last month, services partners across several systems in our community joined [Mecklenburg County Community Support Services](#), [Department of Social Services/Youth & Family Services](#) and the Corporation for Supportive Housing (CSH) for a Keeping Families Together (KFT) Leadership Forum. Karen Pelletier, Community Support Services business manager, served as lead for the day's event.

The forum was built on work the County has been doing regarding identifying families that are the highest users of child welfare and homeless services. Participants spent the morning reviewing the KFT model, current opportunities and identifying next steps in considering system change. Leadership from Youth and Family Services, Criminal Justice Services and the Salvation Army

Center of Hope were part of a Connecting the Dots panel where they shared that the common barrier for family success is housing instability; one that should be viewed as a platform for success.

Next steps include building on the momentum created at the forum and work to engage other partners on how determine reducing barriers for families. Members of this group were assigned tasks and will regroup in the coming weeks to share progress.

Public Art at Second Ward High School Gym Honors Legacy of Charlotte's First High School for African-Americans

Residents from across the community packed the recently renovated Second Ward High School Gym in uptown Charlotte last Thursday to help celebrate the installment of two murals honoring Charlotte's first high school for African-Americans.

The murals, created by Charlotte artist Tommie Robinson, are titled "We Too, Shall Rise" and "Go Tigers." The beautiful artwork celebrates the pride of the school's alumni and reflects the rich history of Second Ward High School, which served the community from 1923-1969.

The dedication ceremony featured brief remarks from BOCC Chairman George Dunlap, District 4 Commissioner Mark Jerrell, Tommie Robinson and representatives from Mecklenburg County, ASC and the Second Ward High School Alumni Association. The event also featured performances by the Second Ward High School Alumni Association alumni chorus Soundwaves and spoken word poet Hannah Hasan.
