Brisbane Academy will celebrate its 20th Anniversary and Class of 2012 Commencement Ceremony on May 31, 2012 at 4:00 pm. This is a major milestone in the history of the small preparatory school that sprang from the Brisbane Tutoring Center (established in 1986).



Heeding the request of a number of students from the tutorial program who loved learning, but thrived in a smaller, more individualized setting, Brisbane Academy was established in July 1992. The Academy ended its first year with a total of 13 students in 3rd through 6th grades. By August of 1997, the enrollment had expanded to include students from Pre-K through 12th grades. Currently a total of 76 students are enrolled at Brisbane Academy. Brisbane Academy & Brisbane Tutoring Center have served over 8,500 students, 2,200 of which have matriculated through the Academy, which maintains a 100% high school graduation rate, 100% pass rate of end-of-course testing, and a 95% college admission rate.

As we steadily grow, we need your help!
