Currently in his third term, Josh Stein serves as Senate Democratic Whip. Josh is a powerful voice on the Senate floor where his priorities include strengthening the economy, improving public education, keeping the public safe, and promoting clean energy.

His Republican and Democratic colleagues recently ranked Josh the most effective Democratic Senator; political commentator Gary Pearce named him the Democratic "MVP" of 2013; and Luke Russert of The Daily Rundown with Chuck Todd selected him as a "politician to keep an eye on in North Carolina" who has had a "meteoric" rise in the Senate.

NC law permits contributions up to \$5000 per election from individuals and NC-registered PACS. Contributions from business entities and corporations are prohibited. Cash contributions in excess of \$50 are prohibited. Anonymous contributions are prohibited. Contributions from state-registered lobbyists are prohibited. Contributions from PACs are prohibited when the General Assembly is in Regular Session. State law requires us to use our best efforts to collect and report the name, mailing address, occupation, and name of employer of individuals whose contributions aggregate in excess of \$50 per election. Contributions are not tax deductible.
