Justice Beasley was appointed to the NC Supreme Court in 2012 after having served the previous 4 years on the NC Court of Appeals; and in Cumberland County, she had earlier served as a District Court judge

for 10 years and as a public defender for 5 years. She has dedicated her professional life to public service; she needs to stay on the Supreme Court bench; and we need to work together to ensure that this most important institution maintains a semblance of balance in deciding the most important issues of our day.
