## Re: I really need you at Monday nights City Council Meeting

Thank you to everyone that attended or spoke at tonight's meeting.

I think we took another step forward tonight. Having City Council hear personal narratives from our speakers was really powerful. I wanted tonight to be more about the narrative and less about the applied pressure.

Ms Friday and I have had 1 meeting with Willie Ratchford representing the city, the City Manager and City Attorney have reviewed our ordinance and I wanted tonight to be a chance for the Council to hear from the people without direct action tactics.

The City Attorney has stated that the city will move forward with preparing an ordinance that addresses most of our concerns before the end of the year. We as advocates will continue to work to make sure that all of our concerns are addressed.

I want to share with you what Raleigh passed last week. While I like their ordinance, it does not address surveillance, infiltration of political groups and data collection. Raliegh's ordinance states the following:

ORDINANCE 2014 - 360

AN ORDINANCE TO AMEND RALEIGH CITY CODE SECTION 4-1004. ENTITLED POLICY OF NONDISCRIMINATION

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RALEIGH:

Section 1. That Section 4-1004(a) be deleted and rewritten to read as follows:

(a) The policy of the City of Raleigh is, and shall be, to oppose any discrimination based on actual or perceived age, mental or physical disability, sex, religion, race, color, sexual orientation, gender identity or expression, familial or marital status, economic status, veteran status or national origin in any aspect of modern life.

Adopted: October 21, 2014

We have an oppritunity here in Charlotte to make the best civil liberties ordinance in the state. I know that we are all busy with Get Out the Vote. When the election is over, I think that we need to spend November sending emails to City Council members informing them of what we think should be included in the Charlotte Ordinance. I will be in touch with all of you after the election.
