### General Assembly Update

The State Senate recently introduced economic incentive/tax reform legislation that would cap the amount of tax incentives available to companies in Mecklenburg, Wake and Guilford counties. The plan differs significantly from a previously passed House plan and received criticism from the Governor. Meanwhile, expected legislation for Sen. Harry Brown to reallocate sales tax revenues was introduced today. We will provide an estimate of the fiscal impact on Mecklenburg County and the municipalities to our delegation in the near future.

In addition, staff is working to identify the fiscal impact of legislation that would exempt builders from property taxes for up to five years. We also are analyzing the impact of a proposal to increase the liability of building inspectors and eliminate plan review for residential construction. We are closely following, and preparing to work against, legislation that would subject to a referendum the BOCC's authority to issue certain types of debt. Early this week, the bill was scheduled for a committee meeting, however, a coalition including the North Carolina Association of County Commissioners raised sufficient concerns to delay consideration of the bill.

Finally, Mecklenburg Representative (and former County Commissioner) Becky Carney will once again be one of four co-chairs of the bipartisan and bicameral County Caucus composed of legislators who are former County Commissioners.

### Ramp Installed at Romare Bearden Park

At the Jan. 21 Board meeting, you received a presentation regarding a civil rights complaint about accessibility for people with disabilities at Romare Bearden Park.

Staff recommended the replacement of an existing stair with a new ramp to improve the accessibility to the water feature from Martin Luther King Jr. Boulevard. After an eight-week period of design and construction, the new ramp has been completed and opened for public use.

The new ramp satisfies the original complaint and meets ADA requirements.
