


### General Assembly Update

Last week, the Senate passed its version of H721, "An act to amend the laws related to land development." LUESA staff believes that this legislation will negatively affect a bonding program that they administer on behalf of Mecklenburg's towns to ensure that infrastructure improvements for new subdivisions are completed if a developer exits the project before all required improvements have been made.

The bill narrows the scope of what can be paid for by these bonds, shifting the cost of final improvements to the local government general fund. We shared our concerns about the legislation with the bill sponsors; however, the legislation moved forward without changes. The bill has been returned to the House for consideration of the Senate's changes.

Also, this week, Senator Harry Brown hosted a press conference to discuss his plan to redistribute sales taxes in North Carolina. Under his plan, 87.5% of all sales tax collected in Mecklenburg would be distributed across the state either through the state budget process or the per capita distribution model.

The current distribution method was established in 2007 as part of a complex swap that, unlike the current Senate proposal, was beneficial to all 100 North Carolina counties. We continue to work with counties, municipalities, and businesses from other urban, suburban, rural and tourism counties to oppose this legislation that will hurt the economic engines of North Carolina while providing no long term solution to the challenges facing our rural neighbors.
