Representatives from numerous organizations filled the halls to express their views to North Carolina's lawmakers concerning bills proposed for this short legislative session. Most notably, I along with several other Senators from the Legislative Black Caucus, hosted a Divine Nine Legislative Day on Wednesday, May 18. Esteemed members and UNC System alumni from the National Pan-Hellenic Council's (NPHC) Nine Fraternities and Sororities came to Raleigh in full force to express their views and concerns about proposed legislation that may have some adverse effects on our state's Historically Black Colleges and Universities (HBCUs).

Providing North Carolinians with access to affordable quality education is greatly important. I will continue my efforts this session to make cost-effective higher education a reality for our citizens and protect the traditions, standards, and values of our state's Historically Black Colleges and Universities.

Session News

Health Director authorization to prescribe opioid antagonist, also known as naloxone hydrochloride. This FDA-approved drug is administered through injection or as a nasal spray and used to prevent people from overdosing on opiate substances. It would allow pharmacists and qualified practitioners to supply naloxone hydrochloride to individuals at risk of overdosing or anyone in a position to prevent a person from overdosing. Senate Bill 734 passed the Senate on May 17, 2016, and is currently in the House for further discussion.

- Conform Full-payment Check Law to UCC (Senate Bill 807/ House Bill 1060) This proposed legislation is designed to align state law with the Uniform Commercial Code (UCC) on debt collection procedures. The claim would be discharged if the person against who a claim for collection is filed can prove that written communication suggests the end of the agreement was satisfied. A claim for collection would not be discharged if a statement of cleared debt had been filed but not received by the indebted party. The claim would also not be discharged when the claimant proves that within 90 days after payment of the instrument, the claimant repaid the amount of debt to the person against who the file is asserted. Senate Bill 807 passed the Senate on May 17, 2016, and is now in the House for review. I voted in support of this legislation.
- Prevent Squatting in Foreclosed Real Property (Senate Bill 754) This legislation would enhance criminal penalties for individuals that file false liens or encumbrances against real or personal property. The clerk of superior court may refuse to file a lien if there is reasonable suspicion that it is illegitimate. If a judge approves the filing of a suspicious lien after finding that it is legitimate, the clerk shall document the lien and file it. If the court finds that there is no contractual requirement related to the lien, it will be returned to its sender. The sender will have 30 days to appeal their claim. The bill also penalizes individuals who commit a trespass to real property and reenters after having previously been removed pursuant to the execution of a valid order or writ for possession. A person in violation of this legislation would be guilty of a Class I felony and would have to pay a minimum fine of \$1,000. This legislation is currently in the Committee on Appropriations/Base Budget.
- Exclude Yr-Round Track-Out Program/Child Care (House Bill 474) This legislation explains the type of programs that do not constitute the provision of child care track-out programs for children who attend year-round schools. It alters the child care section of the general statute by stating that track-out programs for children in year-round school would no longer be classified as child care programs. I voted in support of this legislation. House Bill 474 was ratified and signed by the Governor on May 25, 2016.
- Student Online Protection Act (Senate Bill 534/House Bill 632/S.L. 2015-133) This bill proposes to establish an oversight committee to make recommendations to the General Assembly on issues relating to the privacy of online student data. It includes provisions that would aim to protect student online data from operators of third-party online educational applications that advertise to students based on the site locations that they visit. It prohibits operators from engaging in targeted advertising, creating a student profile from online data, selling or renting student information, or disclosing covered information. This legislation requires that these operators delete student information within 45 days of the request to do so. An operator may only disclose information to another K-12 local school administrative unit for K-12 purposes. Operators may use or share covered information that is not associated with an identified student within the operator's site and recommend additional services or content related to an educational, learning or employment opportunity. I voted in support of this legislation. Senate Bill 534 will go into effect on October 1, 2016.
