Each row is an independent calculation and represents a distinct count of students suspended for the offense type/category named for that row. Because incidents can be recorded and classified as having multiple offense types, students will be counted as having a suspension for each offense type an incident (resulting in suspension) is recorded as having in PowerSchool. Therefore, the sum of the rows in any demographic category will exceed the actual/distinct overall number of students suspended.

This report counts the number of students suspended, not number of suspensions or incidents. A student will only be counted once for each offense type resulting in a suspension. For example, if a student is involved in three separate fights, that student will only be counted once as having a suspension resulting from fighting.
