County Sells General Obligation Bonds

Mecklenburg County successfully sold \$200 million General Obligation (GO) bonds for educational purposes on Thursday, Sept. 29. The winning bidder was Citigroup Global Markets with interest rates ranging from 2 percent to 5 percent and a true interest cost of 2.2810 percent. By comparison, the Bond Buyer Index is 2.98 percent. The final maturity of the bonds is 2035 resulting in 12.38 years as the average life of the bonds. These bonds were rated AAA by Standard and Poor's, Fitch Ratings and Moody's.

This sale follows the successful \$148.5 million Refunding Bond sale on Sept. 14 to refund \$168.5 million of GO bonds to achieve interest savings and fix some variable rate bonds. The underwriters for the refunding issue were Wells Fargo and Citigroup. This negotiated sale resulted in \$4 million net present value of savings.
