Legislative Update

The General Assembly convened for the first day of the 2017-2018 legislative session this past Wednesday, Jan. 11. Many family members and close friends joined the elected officials on the floor of the House and Senate chambers, which created a fun atmosphere on Jones Street.

No substantive bills were taken up, as this was an organizational day to establish rules and elect the leaders of both chambers. House Speaker Tim Moore and Senate President Pro Tempore Phil Berger were reelected to lead their respective chambers. Rep. Sarah Stevens (R-Surry, Wilkes) was elected speaker pro tempore of the House and Sen. Louis Pate (R-Lenoir, Pitt, Wayne) was reelected deputy speaker pro tempore of the Senate.

Members will have two weeks off before they return to the capitol on Jan. 25.

In addition, the North Carolina Association of County Commissioners (NCACC) held its 2017 legislative goals conference on Thursday and Friday of last week, the purpose of which was to finalize the NCACC's legislative priorities for the 2017 long session. More than 80 percent of North Carolina's counties were represented at the conference – including Mecklenburg – which was a solid turnout for the association. From Mecklenburg, Commissioners Dunlap and Fuller attended. The NCACC approved 25 legislative goals for 2017, including a goal seeking increased state funding for early childhood education – aligning with Mecklenburg County's 2017 legislative agenda. The NCACC also added a new goal to its 2017, which was raising the juvenile age from 16 to 18 for all criminal offenses except for felonies.
