Legislative Update

The North Carolina Senate moved closer to further lowering the state's corporate and personal income-tax rates, passing what leadership has named the "Billion Dollar Middle Class Tax Cut," or Senate Bill 325. No Senate Democrats supported the measure. The bill has passed the Senate and is now in the House.

The House purportedly plans to lower the corporate and personal rates as well, but to a lesser extent. If SB 325 passes the House in its current form, the personal income tax rate would go from 5.499 percent to 5.35 percent and the corporate tax rate would go from 3.0 percent to 2.5 percent by 2019. The bill would also increase the standard tax deduction for married couples filing their taxes jointly – from \$17,500 to \$20,000. Accordingly, married couples earning less than \$20,000 a year would not owe any income taxes.

A bill has been filed in the North Carolina Senate that would significantly change the way that handguns and other weapons are permitted in North Carolina. Senate Bill 503, titled Online Paperless Pistol Modernization, would do away with the current paper permitting process that runs through the Sheriff's Office.

In lieu of paper permits, gun dealers would run their own national background checks on the purchaser of the weapon and electronically send the results to the Sheriff's Office. The bill sponsors have emphasized that this will bring North Carolina up to speed with the other 49 states, as North Carolina is the last state in which a paper handgun permitting process exists.

The North Carolina Sheriffs' Association opposes the bill, stating that the national background checks run by gun dealers are liable to miss local criminal misconduct.

The North Carolina General Assembly is expected to take an unofficial spring break from April 12 – 18.
