**Dear Friends:**

On March 29, I held a press conference with retired school personnel and government employees to discuss the need for a cost-of-living increase. I introduced [Senate Bill 314, Give Retirees Two Percent COLA/Funds](#), which would provide a two percent cost-of-living adjustment (COLA) for retired teachers and state employees. State retirees have not seen a two percent increase in their pension since 2009. Retired employees contributed six percent of their salaries into retirement funds during their careers.

It is time to show our appreciation to those who have dedicated years of service to our state. As retirees age, the costs of healthcare, medication, and other expenses have increased. We must ensure that state retirees have the same purchasing power no matter how quickly the prices of goods and services may rise. We must continue to support measures that will account for the effect of long-term inflation.

I cannot achieve anything without the support of my constituents. Thank you very much for your continued support!

Legislative Update

- [LRC/Strengthen Savings Reserve \(House Bill 7/Senate Bill 14\)](#) – This legislation sets ground rules on how the state government will save money in case of a fiscal emergency. The bipartisan measure requires the automatic transfer of a set amount of funds each fiscal

year to the Savings Reserve. It also limits the uses for which funds in the Savings Reserve may be expended. This legislation passed the House and Senate. It currently awaits the Governor's signature. I voted in support of this bill.

- **[Habitual Felons/Clarify Previous Convictions \(Senate Bill 223\)](#)** – This bill clarifies which prior criminal convictions may be used to establish habitual felon status. Any person who has been convicted of or pled guilty to three felony offenses in any federal court or state court in the United States is considered a habitual felon. Aside from specific exceptions, a felony offense would include:
 - a. A felony in this state.
 - b. A felony in another state that is substantially similar to a felony in North Carolina.
 - c. A felony under federal law.
 - d. An offense similar to a felony in North Carolina, punishable by imprisonment for more than a year in a state that does not use the classification of felony.

This legislation passed the Senate unanimously on March 27. It is currently in the Committee on Judiciary II in the House.

- **[Billion Dollar Class Tax Cut \(Senate Bill 325\)](#)** – This legislation reduces the personal tax rate from 5.499 percent to 5.34 percent and expands the standard deductions for all personal income tax filers. Currently, the standard deduction is \$17,500 for married filing jointly taxpayers and \$8,750 for single filers. Senate Bill 325 increases these standard deductions to \$20,000 and \$10,000, respectively. It also reduces the income tax rate for corporations from 3% to 2.75% in 2018 and 2.5% in 2019.

The General Assembly's Fiscal Research Division highlighted that the annual cost of the tax plan would grow up to \$839 million in lost revenue by 2022. The enactment of large tax cuts would make it harder to balance the budget in the long term and meet increasing demands of a growing population. Senate Bill 325 passed the Senate on April 6, with all Democrats opposing the measure. It will be sent to the House for further review.

- **[Reset of S.L. 2016-3 \(House Bill 142\)](#)** – Finally, after a year since its passage, [House Bill 2, Public Facilities Privacy & Security Act](#), is removed from the books. House Bill 142 passed the Senate 32-16 then passed the House 70-48.

House Bill 142 was a compromise to end the economic damage hurting our families and businesses. It makes progress toward our ultimate goal. I voted in support of this legislation. By repealing House Bill 2, this bill reinstates Charlotte's non-discrimination ordinance as it read prior to February 22, 2016. That means that a place of public accommodation (i.e., "a business, accommodation, refreshment, entertainment, recreation, or transportation facility ... whose goods, services, facilities, privileges, advantages or accommodations are extended, offered, sold or otherwise made available to the public") may not discriminate based on race, color, religion, national origin, or sex. Complaints of discrimination may now again be filed with the City's Community Relations Committee which will investigate and bring an enforcement action if warranted. This is not the end of our work to make North Carolina better, and we will continue pressing to make our state a more welcoming and fair place.

Here is an overview of the differences between House Bill 2 and House Bill 142:

House Bill 2 Versus House Bill 142

Bathroom access: House Bill 2 requires all multiple-occupancy bathrooms, locker rooms and changing rooms overseen by state agencies, cities, counties and school districts be designated for use by a single gender based on what's listed on a person's birth certificate. House Bill 142 says only the General Assembly can establish access rules for public bathrooms.

Nondiscrimination ordinances: House Bill 2 established a statewide nondiscrimination policy for employment and public accommodations based on "race, religion, color, national origin, age, biological sex or handicap," leaving out protections based on sexual orientation or gender identity, and it barred cities and counties from going beyond the state policy. House Bill 142 repeals the statewide policy and blocks all local nondiscrimination ordinances until Dec. 1, 2020, but places no restrictions on them after that date.

Local contracts: House Bill 2 prohibited local governments from setting rules for private contractors regarding minimum wage and worker benefits. As part of its repeal provision, House Bill 142 does away with this and doesn't replace it.

Governor Roy Cooper Vetoes House Bill 100

CHARLOTTE, NC – On March 16, Governor Roy Cooper signed his first veto of House Bill 100, which would restore partisan elections in Superior and District Courts. The bill requires District and Superior Court judicial candidates to go through a party primary which would include the candidate's party affiliation on the general election ballot. Candidates who are unaffiliated must follow a petition process to have their names listed on the ballot.

Governor Cooper wrote in a news release, "North Carolina wants its judges to be fair and impartial, and partisan politics has no place on the judges' bench. We need less politics in the courtroom, not more. Judges make tough decisions on child abuse, divorce, property disputes, drunk driving, domestic violence, and other issues that should be free from politics. This bill reverses that process."

State legislators switched the Superior Court elections from partisan to nonpartisan in 1996 and made the same change for District Court in 2001. House Bill 100 passed the Senate, 32-15, along party lines with Democrats opposing the change. The legislation passed the House, 74-43, then was presented to the Governor. A three-fifths vote of both the House and Senate Chamber is required to override the Governor's veto.

"I support Governor Cooper's decision to veto House Bill 100. Judges should be elected based off of their professional history. Politics should not be considered in judicial elections," said Senator Joyce Waddell.
