On Monday, the Supreme Court ruled that District 1 and District 12 of North Carolina's congressional maps were unconstitutionally drawn with racial bias. The Supreme Court ruled 8-0 to strike down the District 1 map and 5-3 to toss out the District 12 map. The decision affirmed the ruling of the lower courts which ordered the General Assembly to redraw the Congressional districts in 2016. The 1st Congressional District covers the northeastern part of North Carolina. The 12th Congressional District is located in the western and central parts of the state, including Charlotte and Winston-Salem.

In another ruling issued on May 15, the Supreme Court refused to revive a restrictive North Carolina voting law that a federal appeals court in Richmond pinned on the state as an unconstitutional effort to target African-Americans and suppress their vote. In 2013, the appeals court ruled five parts of the Voting Rights Act Law: photo ID requirements, a rollback of early voting from 17 to 10 days, elimination of same-day registration and preregistration of some teenagers, and its ban on counting votes cast in the wrong precinct.

In July 2016, a panel of three federal judges from the U.S. Court of Appeals for the Fourth Circuit deemed North Carolina's Voter ID Law unconstitutional. The court found that all five restrictions unduly affected African-Americans. Unfortunately, legislative Republicans have repeatedly sought to limit access to voting along racial lines and rig elections for political gain. Governor Cooper and Attorney General Stein made the right decision in withdrawing from the state's appeal of this discriminatory legislation.

Legislative Update

- [Allow Restaurants to Use Outdoor Grills \(Senate Bill 24\)](#) – Currently, restaurants are not allowed to serve food using an outdoor grill. This legislation would allow food establishments to use outdoor grills for food preparation if the following conditions are met:
 - The grill is located on the premises and is continuously supervised by an employee while in use.
 - The cooking surface is stainless steel or cast iron, meets sanitation requirements, and is on a concrete or asphalt foundation.
 - The grill is not operated within 10 feet of combustible construction.
 - All open food and utensils have overhead protection.
 - The grill is kept in an enclosed area when not in operation.
 - The grill and foundation are cleaned daily on days that it is used.
 - Raw meat, poultry and fish are prepared in a pre-portioned or ready-to-cook form and may only be handled with utensils at the outdoor grill.
 - Food prepared on the grill must be processed inside the permitted establishment.

Senate Bill 24 passed the House and Senate unanimously. The Governor signed the bill into law on May 23, 2017.

- [Law Enforcement Authority/Custody of Child \(Senate Bill 53\)](#) – This legislation would authorize a law enforcement officer to obtain custody of a child upon determination by the court that the child is in danger. The bill would require a temporary custody order be accompanied by a warrant to take the child into custody. It would authorize officers to execute the warrant to take custody of the child without further verification of the order if it appears regular and complete on its face. It would also provide civil and criminal protection for an officer executing the court's warrant to take custody of the child. I voted in support of this legislation. Senate Bill 53 passed the House and Senate. The Governor signed the bill into law on May 23, 2017.

- [QZAB Use Modification \(Senate Bill 468\)](#) – This legislation amends the proposed conditions for the usage of funds allocated under the Qualified Zone Academy Bond (QZAB) program to further prioritize distribution to schools where 75% or more of the school's students are eligible for free or reduced lunch under the federal lunch program. Senate Bill 468 would expand the purposes for which QZABS may be issued to include all the permissible uses of a QZAB allocation under federal law. Those additional purposes would include, in addition to rehabilitation or repairing of a school facility, equipment, course materials, and teacher training. Senate Bill 468 passed the Senate unanimously on May 12, 2017. It will be sent to the House for further review.

- [Streamline Dam Removal \(Senate Bill 107\)](#) – Senate Bill 107 would amend State law on dam removal to expedite the removal process under certain circumstances.
 - Section 1 would establish a fee for a professionally supervised dam removal of \$500.00 and make other conforming changes.
 - Section 2 would provide that, except as required by federal law, Department of Environmental Quality (DEQ) will not require mitigation for impacts associated with the removal of a dam that is done in compliance with State law. Section 2 would also direct DEQ to develop a water quality certification that would allow short term sediment releases associated with a professionally supervised dam removal if the sediment to be released has a similar or lower levels of contamination

than the sediment downstream of the dam.

- Section 3 would provide that for purposes of implementing professionally supervised dam removals the height of a dam is measured from the lowest point on the crest of the dam to the lowest point on the downstream toe.
- Section 4 would direct DEQ and the Department of Public Safety (DPS) to jointly study the dam removal process in North Carolina and recommend further changes in statutes or rules to reduce the regulatory barriers to the removal of obsolete and unwanted dams and consolidate duplicative permit processes. The Departments would jointly report the results of the study to the Environmental Review Commission no later than March 1, 2020.

Senate Bill 107 passed the Senate unanimously on May 11, 2017. It will be sent to the House for further review.

- **Clarify HUT & Improve Vehicle Titling Process (Senate Bill 326/House Bill 421)** – Senate Bill 326 would clarify the application of the highway use tax to out-of-state vehicles titled in this State, and it would eliminate duplicative and unnecessary information on an application for a motor vehicle title.
 - Section 1 of the bill clarifies that the highway use tax applies to out-of-state vehicles when they are first titled in this State, with the exception of certain vehicles listed below, subject to a cap of \$250.
 - Section 2 of the bill eliminates duplicative and unnecessary statements on an application for a motor vehicle title. The statements are about the vehicle owner's eligibility for liability insurance for the vehicle.
 - Subsection (a) of this section deletes the provisions that impose the requirements to provide statements about whether the vehicle owner is an eligible risk for insurance purposes.
 - Subsection (b) amends the statute that lists the requirements for titling and registering a vehicle to include a cross reference to the basic requirement that the owner have liability insurance.
 - Subsection (c) makes conforming changes to statutes that now refer to the provisions that are repealed by subsection (a).

Senate Bill 326 passed the Senate unanimously on May 11, 2017. It was sent to the House Committee on Finance for further review.
