Legislative Update

The North Carolina House of Representatives passed a concealed carry bill that would allow North Carolinians to carry a concealed weapon without a concealed carry permit. While the bill passed the House, it was a relatively close vote that did not enjoy overwhelming GOP support, falling short of supermajority support. This means that even if the Senate passes the bill soon and the governor vetoes it, the chances of a gubernatorial veto being overridden are slim.

On the water buffer front, the newest piece of legislation was removed from voting consideration by Senator Tillman (R-Randolph) of the Senate Finance Committee after much pushback. HB 56 would exclude thousands of parcels of property in Mecklenburg County from taxation, with an anticipated negative impact of \$2.5 to \$3 million to Mecklenburg County annually. The resulting tax burden would then be passed on to other residents of Mecklenburg and beyond.

The legislature is still rumored to be on track for adjournment by the Fourth of July, which means that a final budget product is expected in the next couple of weeks. Both chambers have agreed on a total budget figure of \$22.9 billion, but as described in [last week's bulletin](#), there are some significant differences in the two budgets with respect to their substantive provisions.

Data Making a Difference: The 2017 BRFSS Survey

Over the next few weeks, Mecklenburg County Public Health will be conducting the Behavioral Risk Factor Surveillance System (BRFSS) telephone survey. This phone survey, which takes about 10 minutes to complete, randomly polls residents aged 18 and older to learn about their health behaviors. Your participation can directly influence health programs and policies for all County residents.

The BRFSS collects information on health risk behaviors and chronic health conditions - information that is critical to understanding the scope of certain issues like diabetes and heart disease.

BRFSS findings are used to evaluate public health programs, establish prevention strategies and drive communitywide policy, programming and campaigns to promote and improve the health of our county.
