

Morrison Regional Library Reopens

Mecklenburg residents got a firsthand glimpse of the newly renovated Morrison Regional Library during a grand reopening ceremony on Dec. 16.

The renovated branch, the third most active in the library system, increased by 2,600 square feet to nearly 27,000 square feet, and includes redesigned spaces for children and teens, a maker space room, a vending café, and a patio and terrace. There is a wide selection of books and audio-visual materials including DVDs, CDs and audiobooks. Features include a new computer lab, a laptop check-out system, an automated materials handling unit, WiFi availability, and the ability for wireless printing from personal devices.

Morrison Regional Library is open Mondays through Thursdays from 9 a.m. to 8 p.m.; Fridays and Saturdays from 9 a.m. to 5 p.m.; and Sundays from 1 p.m. to 5 p.m. Hours may vary in summer.

Public funding for the \$8-million project was approved in 2014 as part of the 2015 Mecklenburg County Capital Improvement Program (CIP). The renovation is the first of several projects in the 2015 CIP for the Charlotte Mecklenburg Library system. In addition, Mecklenburg County has earmarked funding for a new main library.

Energy Assistance Applications Being Accepted Now

Mecklenburg County's Department of Social Services will be taking Low Income Energy Assistance Program (LIEAP) applications from residents. The LIEAP is a federally funded program that provides a one-time vendor payment to help eligible households pay their heating bills.

In December, priority in eligibility will be given to persons with disabilities who receive services through the Division of Aging and Adult Services, or households in which a member of the household is age 60 or older. Applications for those households will be taken Dec. 1-31 or until funds are exhausted.

Applications for all other households will be taken from Jan. 1 through March 31, 2018 or until funds are exhausted.

Applicants must meet the following criteria:

- Have at least one U.S. citizen or qualified alien
- Have income below 130 percent of the Federal Poverty Level (FPL)
- Have reserves at or below \$2,250
- Be responsible for its heating bills
