I'm writing to let you know beginning tomorrow, March 8 at 8:00 a.m., Truliant Federal Credit Union will begin accepting applications for the 2018 Community Mini Grants. The program provides funding up to \$1,000 for operating, programming or capacity-building expenses for non-profit organizations.

Criteria:

Applicants must have been in existence for a minimum of three (3) years and have tax-exempt status under section 501(c)(3) of the Internal Revenue Code. Applicants must also provide services in the cities and/or counties where Truliant operates. Consideration will not be given to individuals, political candidates or groups, religious schools or churches, and organizations who do not serve the cities/counties listed above.

Priority Funding for 2018:

Emphasis will be placed on organizations that improve local communities through the following initiatives:

Arts and Culture – organizations that inspire creativity through the arts or introduce audiences to new experiences through cultural programming

Basic Needs – programs that address the most basic of needs including hunger, shelter, employment, housing and youth programs

Financial Education – organizations that provide financial education to improve the lives of individuals served
