### Legislative Update

The short session of the North Carolina General Assembly will convene next month on May 16. The rules of the short session restrict most bill deliberation to bills affecting the state budget, bills that passed at least one chamber in the previous session or local bills signed by every representative from the affected area.

To prepare for the session, the Intergovernmental Relations Committee will meet tomorrow at 2 p.m. in the large conference room on the 11th floor of CMGC to consider the County's legislative priorities. A breakfast with the Mecklenburg Legislative Delegation will also be held at MEDIC on Friday, May 11. This will be an engaging opportunity to share priorities with the delegation.
