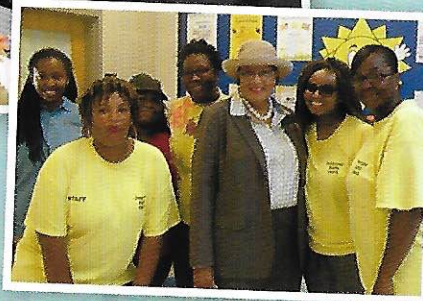

Legislation Introduced

- Protecting Education and Pathways to Opportunity Tax Amendment Package: protecting students, teachers and schools from dangerous tax cuts

- Veterans Small Business Tax Credit Act: making it easier for veterans to start small businesses
- Affordable Housing Resolution: affirming Congress' commitment to end homelessness in America
