State and Federal Legislative Update

State Update

The General Assembly informally concluded its business for the 2017-2018 biennium.

During the recent three-week reconvening, the Senate and House considered a variety of issues, including many related to the recently passed constitutional amendments.

Bills passed by both chambers have been sent to the governor. The General Assembly will return by Dec. 31, 2018 to address any bills vetoed by Gov. Cooper.

The 2019-2020 session will begin in mid-January. The County looks forward to working with its delegation.

Federal Update

This past week, Congress approved a \$867 billion farm bill. The primary role of the bill is to allocate funds to American farmers. However, it also includes provisions for the Supplemental Nutrition Assistance Program (SNAP) which so many of our residents depend on for subsistence. During Senate and House deliberations, the County shared concerns regarding the impact that suggested funding cuts and stricter work requirements would have on children, adults and families in Mecklenburg. Fortunately, the suggested cuts and stricter work requirements weren't included in the final bill that passed. We appreciate the opportunity to provide comments to members of our Congressional delegation on the critical issues that affect our County.

Air Quality Staff Leading Effort to Create 'Breathing Room'

During ozone season 2018, Mecklenburg County remained in compliance with the health-based standard for ground-level ozone. The County's compliance value of 70 parts per billion (ppb) narrowly meets the 70-ppb health standard set by the U.S. Environmental Protection Agency (EPA). However, Mecklenburg County experienced five days when air quality was unhealthy for sensitive groups (e.g. seniors, children, asthmatics).

County Air Quality staff are working to identify ways to put "Breathing Room" between local

compliance values and the health-based ozone standard. A review of existing stakeholder-developed plans that align with air quality, like <u>Livable Meck</u>, led to 15 strategies that will reduce local air pollution. To prioritize these strategies, Air Quality has solicited input from over 450 stakeholders ranging from middle and high school youth, to elected officials and city planners, to business leaders and manufacturing workers. Public input is still ongoing and will shape the future of Breathing Room. This path forward will be presented to the Board in early 2019.

Work on Breathing Room is being completed in line with <u>LUESA's</u> Strategic Business Plan (Goal 3, Objective 1) and the EPA's Ozone Advance program.
