Last week, The Mecklenburg County Assessor's Office mailed Notices of 2019 Real Estate Assessed Value to nearly 400,000 property owners across the County. These new values are also available online at MeckReval.com. It is important for property owners to remember that the notice is NOT a bill.

Property owners who have questions or just want to learn more about their new assessed values are invited to attend a listening session during the month of February. Each session takes place from 6-8 p.m. No RSVP required.
