

Monday, February 25, Governor Cooper issued a call to use that determination to expand access to quality education and health care, create good paying jobs and build an economy that works for every community in our state.

Proposal included:

Medicaid Expansion

- Expanding Medicaid would bring \$4 billion into our economy and expand access for more affordable care for 500,000 working people.
- This will bring thousands of new jobs, help rural hospitals stay open, and ensure that our people are healthier.

Investing in Our Schools

- Too many students attend aging schools in need of repair. Every student and teacher in North Carolina deserves to work and learn in a safe, modern school.
- The smartest method to ensure that schools can be repaired and built is through a school bond. This would also not affect teacher pay and other budget cuts that are vital.

• Continuing the work through the Office of Recovery and Resiliency to ensure that families and communities are more prepared for future storms and lessen the burden of recovery.

Session News

- **Senate Bill 50, Reinstate Earned Income Tax Credit**, reenacts the earned income tax credit for individuals. This bill increases the earned income tax credit at 5% which was previously 4.5%. This would be in effect for taxable years beginning on or after January 1, 2023.
- Senate Bill 55, Continuing Education for General Contractors, an act to revise the law governing the licensure of certain general contractors to require continuing education for the purpose of enhancing the professional competence and professional responsibility of those licensees.
- Senate Bill 19, Repeal 2015 Law Relating to Monuments, an act to repeal the 2015 Law relating to the protection of Monuments and memorials. Previously the law enacted regulations limiting the removal of objects of remembrance, and procedures for approval of memorials, monuments and works of art concerning the protection of historic landmarks.
- Senate Bill 72, School Calendar Flex/ Charlotte-Mecklenburg, provides flexibility for schools to adopt school calendar. This bill would apply to the 2019-2020 school year allowing Charlotte-Mecklenburg schools additional flexibility in determining the opening and closing dates of the school year.
- Senate Bill 70, Erosion & Sedimentation Program/PED, is an act to improve the state's erosions and sedimentation programs. Directs the Division of Energy, Mineral, and Land Resources (Division) of the Department of Environmental Quality (DEQ) to study the adequacy and compliance with reporting requirements for delegated local erosion and sedimentation control programs. Base on the study advises the Sedimentation Control Commission to issue rules revising the delegated local program reporting requirements and amend existing agreements with delegated local programs to incorporate the revised requirements. Requires the Division to report to the specified NCGA Committee by January 1, 2020.
- Senate Bill 64, DPI/EC DIV. Feedback/DIT Study/PED report, requires the Department of Public Instruction (DPI) to develop a system

of evaluation for the division's technical assistance and support programs to local education agencies. In addition, this bill would direct agencies to study the feasibility of local education agencies participating in the NC Health Information Exchange Network (HIE Network, known as NC Health Connex) as Medicaid providers of healthcare services to students.

- Senate Bill 58, Revise Marijuana Laws, was introduced to increase the amount of marijuana that may be legally possessed for personal use. Including the authorization for a person convicted of such a violation may file a petition in the court of the county where they were convicted for expunction of the offense from the person's criminal record and any other official record containing an entry relating to the person's apprehension, charge, trial, or conviction.
- Senate Bill 82, Dismissal or Not Guilty/Automatic Expunction, would provide for the automatic expunction of certain records of a person when the charge or charge against a person are dismissed or found not guilty. This bill would make specified confidential files electronically available to all prosecutors if the criminal record was expunged on or after July 1, 2018.
- Senate Bill 60, Restore Educational Sales Tax Holiday, calls to reenact the sales and use tax holiday for school supplies. This would be effective July 1, 2019 and applicable to sales made on or after that date.
- Senate Bill 101, PED Oversight/EPP Changes, regards accountability for educator preparation programs (EPP), performance standards and data reporting systems. Requires the State board of Education to develop a new performance-based weighted model for comparing the annual EPP report card data.
- **Senate Bill 87, ABC Laws Modernization/PED study**, this bill would require the merger of ABC systems in a county with two or more ABC systems. Including the option of operating ABC stores on Sundays and liquor tastings in store.
