Dear Friends and Supporters,

It's hard to believe it that it has been a year and a half since our historic victory. We are already hard at work on my re-election campaign. Of course, that doesn't impede my day-to-day service.

In fact, Monday, June 24th, in an 8 to 3 vote, the Charlotte City Council approved changes to the city's noise ordinance banning amplified sound within 150 feet of schools, places of worship and medical facilities.

I am a fierce advocate of women's equality and rights.

As I stated from the dais, "This is an issue of access to healthcare. We in City Council are not in a business to provide healthcare services. However, we are in the business of ensuring all residents have access to healthcare in a safe and respectful manner. The update to the noise ordinance does not conflict with the first amendment, but rather ask that both sides are peaceful in their protest."
