Census Letters Mailed Mid-March

The Census Bureau will begin sending invitations in the mail urging residents to participate in the 2020 Census.

The Bureau will begin mailing the invitations on Thursday, March 12.

The results from the 2020 Census will be used to direct federal funds to local communities for schools, roads and other public services. Census data also helps to determine the number of seats each state has in the U.S. House of Representatives.

There are three ways to respond to the Census:

- online (visit 2020census.gov to access and complete the census questionnaire online),
- by phone – your invitation will include information about how to respond by phone.
- by mail – complete the questionnaire and follow the instructions for responding.
