We, the Census 2020 Block Party Tour task force team, are continuing to prepare for the 4 community stops, and we understand that you may have concerns about these public gatherings given the recent spread of COVID-19 (coronavirus) in North Carolina and around the country. Our team is taking this health risk very seriously. The following precautions will be taken during the Block Parties:

- The first Block Party at Grier Heights originally scheduled for March 21st will be rescheduled for May 16th. All other dates remain the same until further notice.
