COVID-19 Update: Phase Three?

North Carolina was expected to move to Phase Three for reopening this Friday, however, **hospitalizations, number of cases, and positive test percentages are all on the rise**. Because of this, Governor Cooper has announced that North Carolina will remain in Phase Two for another three weeks and is making wearing facemasks a requirement in public places.

Legislation Watch: Accessible, Affordable Internet for All Act

This week, Rep. Clyburn (D-SC) introduced comprehensive legislation to provide rural and underserved communities with affordable high-speed broadband internet service. Before the health crisis, having internet access was critical to finding jobs or for students to complete their homework, but [19 million Americans do not have access to the internet, and one-fourth of rural residents are not connected to the internet.](#) And now, those needs have been amplified ten-fold. **Cynthia understands how vital bridging the digital divide is to give everyone an opportunity to succeed**, which is why legislation such as the Accessible, Affordable Internet for All Act is a central issue in her campaign. **When elected, she will proudly cosponsor this bill, and fight to ensure it becomes law.** [You can watch Rep.
