Education: Bachelor's Degree in Education, Psychology, Public Health, or Human Service Field desired.

**Experience:** A passion for mental health education and advocacy is essential. Demonstrated fluency in English and Spanish (spoken and written) is a requirement. Self-directed individual with at least 3-5 years in the mental health or related human services field, with progressive responsibilities in public health, human/social services, or similar community-based program planning, training/public speaking, and evaluation. Demonstrated ability to establish and maintain effective working relationships with internal staff, community-based, and private sector organizations. Candidates with prior community engagement and training/facilitation/teaching experience are preferred. Candidates must exhibit cultural competence and the ability to with diverse populations.
