COVID-19 Update

As of 8:30 a.m., there were 71,823 cases of novel coronavirus (COVID-19) with 640 deaths due to COVID-19 reported among Mecklenburg County residents.

COVID-19 Vaccination Update

Last week, Public Health relocated the County's vaccination clinic to Bojangles' Coliseum to better accommodate clients. On January 6, in addition to vaccinating individuals in Phase 1 a, Public Health began vaccinating individuals 75 years of age and older as outlined in Phase 1b of the vaccination plan.

At this time, COVID-19 vaccine appointments through January 30 for those ages 75+ have been filled. As vaccine supply increases, we will add additional appointments and notify residents when they become available. The appointment scheduling process will be available online here and by calling 980-314- 9400.

In the meantime, those ages 75+ are encouraged to reach out to their primary care providers (if they have one) to discuss options for receiving the vaccine.

Both Atrium Health and Novant Health will be offering vaccines to patients in this phase.

Community Development Block Grant funds are intended to create sustainable and viable communities. Funds are targeted to low and moderate-income neighborhoods. Project funding is available to area nonprofits and local governments whose projects meet the criteria listed here in the CDBG FY21-22 Notice of Funding Availability. A

project must meet one of the federal requirements listed in this notice to be eligible for CDBG funds.

Funding is available in a limited target area. Eligible neighborhoods and/or beneficiaries must be located in Cornelius, Davidson, Huntersville, Matthews, Pineville, or the unincorporated portions of Mecklenburg County.

Criminal Justice Services Seeks Applicants for New Task Group

Criminal Justice Services will begin accepting applications for its Criminal Justice Community Engagement Task Group on Jan. 25, 2021.

The task group is one of the latest initiatives created by the department through a grant from the MacArthur Foundation's Safety and Justice Challenge.

The goal of the task group is to foster trust and transparency by serving as a liaison between the community and the criminal justice system.

The task group will be comprised of 10 members from the community of diverse backgrounds. Members of the faith community and individuals with lived experience with the criminal justice system are encouraged to apply.

Task group meetings will be held twice a month during the first three months and will transition to monthly meetings after the 90-day period.

Meeting times will range from 90 minutes to four hours. Task Group members will receive a modest stipend for each meeting attended. Stipends will be paid until grant funds are exhausted.

Applications may be found on MeckNC.gov beginning on Jan. 25, 2021. The final day to apply for the task group is Feb. 28, 2021.
