Family Justice Center Initiative



The mission of the Charlotte-Mecklenburg Family Justice Center (FJC) is to support and aid victims of domestic violence (DV), sexual assault, child maltreatment, human trafficking and elder abuse to live free from violence and abuse and hold offenders accountable by providing easily accessible, coordinated, and comprehensive services in a single location.

A Phase I community-based program will provide crisis-focused resources, services, and support needed in the days immediately following victimization (or whenever a Phase I partner becomes aware) in a trauma informed environment with priority placed on coordination of the highest lethality cases.

The Phase 1 planning committee was formed to prepare for the Phase 1 Center project. The planning committee members are:

During Phase I, a small subset of core FJC partners will co-locate and respond to the immediate needs of survivors by providing additional crisis services during the first few days following victimization.

Subsequent to the Phase 1 Planning Committee, the Operations Workgroup/Committee was created and includes the Department of Social Services (DSS) Economic Services Division (ESD) eligibility, Youth and Family Services (YFS) Services and Community Support Services (CSS) representatives. Famatta Galloway, ESD, and Adrian Green, YFS, will manage the assigned DSS Phase I staff. The inclusion of ESD, YFS and CSS services within the FJC is essential to ensure victims are able to immediately care for themselves and their families after abuse. Having these services vailable in the center provide an added layer of security by limiting the victim's need for multiple visits to multiple locations.

DSS and CSS representatives will contribute to planning and implementing processes in phase 1 for the center slated to open in late spring of 2020. The center will be located on the 2nd floor of the child & family services center.

PROGRAM HIGHLIGHTS

ICO4MCH Featured at Statewide Conference

During the November Building Power Across the Spectrum Conference, our colleagues from Improving Community Outcomes for Maternal & Child Health (ICO4MCH) educated HIV advocates on poverty as a social determinant of health.

They delivered an interactive experience to familiarize participants with how poverty is compounded by the impacts of intersectionality. It also explored the contrasts lens of class and the difficulty those who have not experienced poverty have grasping the magnitude of the struggle.

The message that poverty is a social construct that is not just a state of being, but an actual state of mind held by those affected really hit home. Participants left with the charge to take personal and professional responsibility for creating opportunity and being promoters of progress one person, and one encounter at a time.

Edible Landscape Project



The National Association of Counties (NACo) award winning Edible Landscape Project, targets food security in public health priority areas ensuring increased access to healthy, fresh and affordable local fruits and vegetables while diversifying Charlotte's tree canopy. To date a total of four community orchards with a potential reach of over 30,000 people have been established.

The fourth edible landscape and fruit tree orchard was established on Saturday November 2, 2019 at Faith CME Church. A total of 145 edible fruit trees (75) and non-edible canopy trees (70) were planted in a collaborative community engagement style. Mecklenburg County Public Health (MCPH) department, through its Food Security team, partners with several community organizations to create the gardens and orchards (edible landscapes). Partners for the fourth installation included Faith CME, MCPH, Village HeartBEAT, Cooperative Extension, TreesCharlotte, Mecklenburg County Park & Recreation, Novant and The Males Place Inc.

The Edible Landscape Project is an example of how community representatives and food security stakeholders are engaged in the design of an intervention to address a public health priority. The prevention of chronic diseases and food insecurity remains a primary area of concern for the Mecklenburg County Public Health (MCPH) Department. To ensure sustainable installation and conservation, the team will reconvene on Saturday February 1, 2020 for tree care, maintenance and installation of the irrigation system including training of key parishioners. Additionally, Faith CME Church under the leadership of Dr. Sandra Gripper (senior pastor) and the parishioners will do an official dedication of the edible landscape and fruit tree orchard on Saturday February 1,2020

Low Income Energy Assistance Program

LIEAP, the Low Income Energy Assistance Program, begins this year on December 2, 2019 and runs through March 31, 2020. The federally-funded LIEAP provides eligible households with a one-time payment (paid directly to their heating vendor) to offset the high cost of heating during the cold-weather months. Depending on the household's primary heating source, the payment will be \$300, \$400 or \$500 (an increase of \$100 over last year's payments!).

Households containing a person aged 60 or more, or someone receiving disability benefits and services through the NC Division of Aging and Adult Services can apply for help covering the cost of heating their homes starting Monday, December 2, 2019. All households throughout Mecklenburg County can apply from Thursday, Jan. 2, 2020 through Tuesday, March 31, 2020. This year Mecklenburg County will take face to face applications at the Valerie Woodard Center (VCW) Suite 101, 3205 Freedom Drive, Charlotte, NC 28208

Customers presenting at other DSS locations to apply for LIEAP should be directed to the Valerie Woodard Center (VCW) for in person (face to face) applications, or, go online to https://epass.nc.gov/CitizenPortal/application.do to complete, print and mail-in, fax, or drop-off their application at any of our DSS locations. Applications cannot be submitted online at this time.

Homebound elderly or disabled persons unable to apply in person or unable to complete an e-pass application, can contact J1C (Just 1 Call) or our Customer Connection line at 704-336-3000.

Environmental Health Selected for National Program

Mecklenburg County Public Health (MCPH) has been selected to participate as a mentee local health department in the Voluntary National Retail Food Regulatory Program Standards (Retail Program Standards) Mentorship Program. We are one of 37 sites selected to collaborate and partner directly with the National Association of County and City Officials (NACCHO) through support from the Food and Drug Administration (FDA). This project will focus on building capacity for integrating the Retail Program Standards at health departments. MCPH will be matched with mentor Southern Nevada Health District, NV, who will be providing guidance on the Self-Assessment and Standards 3, 7, and 9. NACCHO awarded a grant of \$14,000.00 for the period December 2019 – August 31, 2020.

Youth & Family Services Quarterly Provider Meeting

On October 25, Youth & Family Services (YFS) and Clinical Contractual Services (CCS) held their Quarterly Provider Meeting and the theme was the Family First Prevention Services Act (FFPSA) Legislation and the role of the private child welfare provider. The Family First Prevention Services Act (H.R. 5456 (Family First)) was signed into law as part of the Bipartisan Budget Act on February 9, 2018, as Public Law 115-123. Family First amended Title IV-E and Title IV-B of the Social Security Act to child welfare programs and policy.

This historic reform aims to change child welfare systems across the country by providing services to families who at risk of entering foster care. The U.S. Department of Health and Human Services is responsible for further guidance on Family First.

YFS and CCS hosted this forum within a panel presentation format with distinguished stakeholders. The panel was moderated by Tamika Williams, Associate Director - Child Care, of The Duke Endowment. The panelists included:

Child Support Amnesty Week

During the week of October 21-26, Mecklenburg County Child Support Enforcement (MCCSE) had one of their semiannual 2nd Chance Amnesty Weeks. The 2nd Chance Amnesty Event serves as an opportunity for non-custodial parents (NCPs) to come the office and take the necessary steps to get their child support case(s) back in rightstanding. During this time, payments are accepted at the office, payment arrangements can be made via signing an amnesty agreement letter, and consent orders can be signed to address specific circumstances pertaining to a case. Also, during the event, NCPs with active orders for arrest (OFAs) can make arrangements that can lead to the OFA being stricken. This fiscal year, MCCSE added a new element to the Amnesty Project, genetic testing. This gives NCPs, custodial parents and children an opportunity to come into the office for genetic testing, and all fees during Amnesty Week are waived.

To ensure parents had the opportunity to take advantage of these services, MCCSE opened their doors outside normal business hours: 9 a.m. – 3 p.m. on Saturday, October 26. In addition, over 4,500 letters were mailed. MCCSE collected \$3,495 in child support.

New Program Name – Same Great Services!

As part of the NC Medicaid Managed Care **Transformation** to Prepaid Health Plans (PHPs) Pregnancy Care Management will now be known as Care Management for High-Risk Pregnant Women (CMHRP).



All pregnant women enrolled in managed care through PHPs will continue to receive a coordinated set of high-quality clinical maternity services through Transportation services provided by the MTS the Pregnancy Medical Program (PMP). This program will be administered as a partnership between PHPs and local maternity care service providers. A key feature of the program will be the continued use of the standardized screening tool to identify and refer women at risk for an adverse birth outcome to the CMHRP program coordinated and provided by Local Health Departments (LHDs). Together, these two programs will work to improve the overall health of women and newborns across the awareness about dementia and make the state. More information at

Woodard Community Resource Center (CRC) to tour the facility and receive updates on how Mecklenburg County provides Health and Human Services programming to residents. County Commissioner Elaine Powell, County Manager Dena Diorio, Assistant County Manager Anthony Trotman, HHS Department Directors and Executive staff from various community agencies participated in the meeting.

In addition to touring the facility, Ms. Johnson received information from community leaders from Novant Health, Smart Start, Central Piedmont Community College, Charlotte Works and Communities in School, regarding their partnership with the County in serving residents and the success they have experienced in enhancing opportunities for economic mobility and well-being. Discussions on Early Childhood Education, Foster Care and Adoption and Child Support Enforcement were also held with staff from these program areas.

Ms. Johnson recognized the Mecklenburg CRC as a "national best practice model", and praised County leadership for their innovative approach and commitment to improving the quality of life for County residents, as well as stated the commitment of ACF to move "from a focus heavy on compliance to that of outcomes."

Take-aways from the meeting include:

- 1. National Adoption Day is November 11th. There will be a request to Governor Cooper to have North Carolina participate in the recognition.
- 2. There will be a Regional Childcare meeting in Birmingham later this fall where additional policy support for states will be discussed as well as funding and best practices. Additional information on the use of federal funding versus state funding in North Carolina will be provided.
- 3. The Assistant Secretary is very interested in supporting integration efforts especially as it relates to Child Support and the importance of Fatherhood, and would like more information regarding local needs in this area.
- 4. A new TANF rule will be proposed in a few weeks in which Mecklenburg will provide comment.

A Broad Community Engagement Process Underway for **CoC Governance Charter**

The goal of this work is to develop a new Continuum of Care (CoC) Governance Charter. The CoC Governance Charter identifies the purpose, responsibilities and oversight of the CoC. The CoC is responsible for, among other things, operations (holding regular meetings and adopting a written board selection process); designating a Homeless Management Information System (HMIS); planning; and preparing an application for funding.
