The Centralina Regional Council (Centralina) recently awarded Mecklenburg County with a Region of Excellence award in Cross Community Collaboration for Public Health's community partnerships during the COVID-19 pandemic. County's Criminal Justice Services' S.T.E.P. (Supervision, Treatment, Education, and Prevention) Program Celebrates National Drug Court Month

This May, drug courts throughout North Carolina will join the nearly 4,000 such programs nationwide in celebrating National Drug Court Month. This year alone, more than 150,000 individuals nationwide who entered the justice system due to addiction will receive lifesaving treatment and the chance to repair their lives, reconnect with their families, and find long-term recovery. National Drug Court Month is a celebration of the lives restored by drug court, and it sends the powerful message that these programs must be expanded to reach more people in need.

In 1995, Mecklenburg County's first drug court opened its doors with a simple premise: Rather than continue to allow individuals with long histories of addiction and crime to cycle through the justice system at great expense to the public, use the leverage of the court to keep them engaged in treatment long enough to be successful. Today, drug courts and other treatment courts have proven that a combination of accountability and compassion saves lives while also saving valuable resources and reducing exorbitant criminal justice costs.

Numerous studies have found that treatment courts reduce crime and drug use and save money. Research

shows treatment courts also improve education, employment, housing, financial stability, and family reunification, which reduces foster care placements. Treatment courts represent a compassionate approach to the ravages of addiction.

County Recognizes National Bike Month with Park and Rec Educational Video Series

May is National Bike Month! To encourage more residents to get out on two wheels, Mecklenburg County's Park and Recreation Department, in collaboration with Public Health's Active Living and Injury Prevention team, has launched a series of virtual educational programs. They aim to increase and improve opportunities for physical activity with a focus on bicycle and pedestrian safety.

Community Support Services Announces the Completion of The Evaluate Upstream Blueprint

Mecklenburg County Community Support Services is excited to share that Evaluate Upstream, a year-long, community planning process to develop a comprehensive and sustainable prevention assistance system for Charlotte-Mecklenburg, concluded its work in April 2021. The planning process was funded by a Continuum of Care planning grant from the U.S. Department of Housing and Urban Development and executed by Mecklenburg County Community Support Services (CSS).

Evaluate Upstream had the following goals: to document existing prevention resources across Charlotte-Mecklenburg and determine whether and how they work together; to design an optimally functioning prevention network; and to develop an evaluation framework for an impactful homelessness prevention system in Charlotte-Mecklenburg. The culmination of this work is reflected in the Evaluate Upstream Blueprint, which was released on Thursday, May 6 via the Building Bridges blog on the County's Housing & Homelessness Dashboard.

Evaluate Upstream represents an important milestone in the community fight to end and prevent homelessness. The blueprint forms the prevention pillar of the 2025 Charlotte-Mecklenburg Housing & Homelessness Strategy (CMHHS). The Prevention Workstream of the new CMHHS Strategy will pick up the next stage of the work: to outline the roadmap that will transform the recommendations in the Evaluate Upstream Blueprint into action, embodying both the guiding principles of the blueprint and the core values of the overall planning process. The new division in CSS, focused on housing strategy, policy, and alignment, will be responsible for implementation oversight of the recommendations of Evaluate Upstream.
