First In Families of Mecklenburg County Announces 2022 Summer Camp Scholarships for Individuals with Intellectual/Developmental Disabilities and Their Siblings

February 4, 2022

Charlotte, North Carolina – First In Families of Mecklenburg County (FIF), a project of InReach announces the availability

of Summer Camp Scholarships for individuals with intellectual/developmental disabilities (i.e., Autism, Down Syndrome, Cerebral Palsy, Traumatic Brain Injury, etc.) and their siblings on a **First Come, First Served Basis.**

The 2022 maximum award amount per <u>camper</u> with an intellectual/developmental disability is \$300. The maximum award amount per <u>household</u> is \$500.00 for two or more siblings without a disability living in the same home. The scholarship is open to all ages.

Requirements:

Must complete a First In Families application explaining the need for summer camp funding, then signing the application in all four (4) sections. Access the application here: https://bit.ly/MCFIFapp

- 1. Must live in Mecklenburg County and show proof of residency (i.e., photo ID or current utility bill or signed lease agreement)
- 2. <u>New applicants</u> must provide proof of developmental disability or delay (i.e., signed psychological evaluation or medical record).
- 3. Must provide proof of all household income not

exceeding \$65,000.00 (i.e., 4 weeks of pay stubs and/or SSI award letter, etc.).

4. Must provide proof of summer camp registration. Follow-up with the summer camp director to request documentation of the individual's enrollment and the cost for services.

No phone calls will be accepted. No commitments can/will be made via telephone. Individuals are to submit the FIF application with all required documentation via fax, email, or mail:
