Thank you to WSOC-TV for reporting on the continuing cases of ocular melanoma and the horrible impacts on the Huntersville community. As I explained to reporter Allison Latos, I am disheartened that the [\\$150,000 I requested to fund a study on ocular melanoma](#) was not included in [the budget](#) (one of many reasons why I voted no).

I am passionate about securing funding for OM research because the disease strikes so randomly and is so deadly. **I am not giving up on advocating for OM answers and will continue to file legislation to fund a study on this important local issue.** You can watch the full WSOC-TV interview [here](#).

### Senator Marcus's Bill to Increase Funding for Rape Victims Becomes Law



During short session, I filed [Senate Bill 900, Increase Funding for Rape Victim Assistance](#). North Carolina has the lowest cap in the nation for state support to cover the forensic test kits for sexual assault victims. My bill increased the cap from \$800 to \$1,400 and I am happy to report that the bill was added as an amendment to [HB674](#), which **Governor Cooper signed into law**.

### Colonial Pipeline Updates



Colonial Pipeline provided an update on the gasoline leak and clean-up efforts this morning. Key updates, in their words:

"Working closely with state regulators on the recovery and response effort has been a priority for Colonial, and we are pleased to have reached an agreement with the state to provide the released volume estimate and the methodology used to arrive at this updated estimate. **Following extensive operational data collection and analysis, Colonial determined July 27, 2020, as the start date of this release.** This date was validated by a third-party expert and allowed us to further analyze the operational data to estimate an updated estimated released volume."

**"Colonial has recovered more than 35,500 barrels to date, and we now estimate the released volume to be 47,600 barrels (2 million gallons).** Our commitment to product recovery is evidenced by the volume recovered to date, which is **approximately 75%** of the updated release estimate. We will be here for as long as it takes to remediate the location."

This is the first time I'm aware that Colonial Pipeline has admitted how long the pipe was leaking before the contamination was detected. **Plenty of people, myself included, are deeply disappointed in the 18 day delay**, which we now know allowed at least two million gallons of gasoline to seep into the ground in the Oehler Nature Preserve. **This is the largest gasoline spill in US History, by a lot.** I'm angry that my constituents are the victims of this environmental injury and that we must endure this years-long clean-up. **It's been two years since the leak began and it's frustrating to hear that 25 percent of the spilled gasoline is still on site.**

Colonial will continue to keep DEQ and my office updated on key developments, which I will share with you as quickly as possible.

## Governor Cooper Vetoes Harmful Legislation



Governor Cooper has recently vetoed various harmful bills. I voted no on all of these bills and support the Governor's veto.

- **SB101, Require Cooperation with ICE 2.0.** The bill makes it harder for local law enforcement officers to do their job by undermining relationships with victims and witnesses and also would instill fear in immigrant communities. It attempts to force local sheriffs to do the work of ICE agents.
- **SB593, Schools for the Deaf and Blind.** This bill would inject partisan politics into the Board of Trustees for the School of the Deaf and the Blind.
- **HB49, Concealed Carry Permit Lapse/Revise Law.** I spoke against this bill on the Senate floor because it chips away at commonsense gun safety measures.
- **HB823, Child Advocacy Centers/Share Information.** This is a well-intended bill to better serve children, but due to the hurried conclusion of short session, it has several critical flaws that need to be worked out with DHHS.




## Remember this Number: New "988" Suicide and Crisis Lifeline



**988 is the new three-digit dialing code to route callers to the National Suicide Prevention Lifeline - now known as the 988 Suicide & Crisis Lifeline.** As of this week, it is active everywhere in the United States.

When people call, text, or chat 988, they will be connected to trained counselors that are part of the existing Lifeline network. These trained counselors will listen, understand how their problems are affecting them, provide support, and connect them to resources if necessary. ## COVID-19 & Monkeypox Updates



The [DHHS COVID-19 Dashboard](#), which is updated weekly every Wednesday, shows the following data points:

- Wastewater testing has shown an **increase** to 16.5m particles, compared to 15.8m last week.
- COVID-like illness in hospital emergency departments **remained constant** at 5.5%.
- COVID-19 reported cases for the week **decreased slightly**, from 25,562 to 25,051.
- COVID-19 hospital admissions of COVID-19 patients this week **increased** to 971, compared to last week which was at 895.
- Booster rates are 58% for the total population. We have 77% of adults with at least one dose and 29% of children and teens ages 5-17 with at least one dose.
- The Omicron variant continues to represent the vast majority of COVID diagnoses. BA.5 represents 37% of cases, BA.2.12.1 36%, BA.4 15%, BA.2 10%, and BA.1.1.529 2%.

The North Carolina COVID-19 Vaccine Help Center can also help you make an appointment by calling **888-675-4567**. The help center is open 7 a.m.-7 p.m. on weekdays and 8 a.m.-4 p.m. on weekends.

**Monkeypox vaccines** are free and available in Mecklenburg County, but currently in limited quantities. If you are experiencing symptoms or believe you have been exposed, contact your doctor or local health department. In Mecklenburg, that number is 980-314-9400. 
