Steve,

With the temperatures currently over 90 degrees most days here in North Carolina, it is hard to believe that we are less than 100 days until Election Day on November 8th. Election Day conjures up images of a cold, gray foggy morning that seems so disconnected from our current hot, lazy summer days, and yet our days now, and how we spend our time, are directly connected to the votes cast on Election Day and the choices made.

Though 2018 reversed a declining trend, midterm elections (two years after the presidential election) historically have much lower voter turnout rates than presidential election years. And yet, the races that will be decided this year during the midterm elections are for elected officials whose actions more directly impact our lives than those of the President. From the Board of Education, to the Board of County Commissioners, to the North Carolina General Assembly, these elections are vital; not to mention that this year in North Carolina we are electing one of our United States Senators, all of our US Congressional representatives, and two positions on our State Supreme Court.

The New Rural Project is spending the next (nearly) 100 days engaged in conversation with voters of color to help them understand that no matter the issue that is most important to them, at least one of the offices on their November ballot will be one that is charged with the responsibility of addressing that issue. In July, the NRP Team got to "Chat, Chew and Chop it Up" again as we reconnected with folks from our first Barbershop Conversation: Fruitful African American Discussions on Empowerment (F.A.D.E.) in Anson County for our first F.A.D.E. Reunion. After the four week series ended in April, several of our Anson F.A.D.E. participants were inspired to continue their civic engagement by launching the Sandhills Voter Initiative! They are hard at work putting together their introductory event - an Anson High School Alumni Basketball Tournament in Wadesboro in September, where civic organizations will be sharing information, registering voters, and helping Get Out The Vote in Anson County for November.

## CIVIC ENGAGEMENT

For this electoral cycle, the NC Supreme Court struck down the gerrymandered maps drawn by extremist politicians in Raleigh, but the US Supreme Court took up the Moore v. Harper case which may overturn that decision, dramatically changing how federal elections are conducted and giving state legislatures broad, unchecked power over future elections.

On Tuesday, August 9th, we are jumping into action partnering with Common Cause NC, the Southern Coalition for Social Justice, and the Moore County NAACP to kick off a state-wide #MapOurFuture barnstorming tour, People Over Politics: the Moore v. Harper case.

We started F.A.D.E. to help communities leverage their civic power from voting to serving on vital decision making boards! Thank you to our co-chairs barbers, Sheldon "Dee" Rogers and Chris Dawson, and our Scotland Program Assistant, Rev. Gregory Taylor, for making this effort so successful!

### Advocacy & Partnership

New Rural Project joined the North Carolina Justice Center, Every Child NC Coalition, and 143 other ally organizations in signing on to a Brief of Amicus Curiae filed with the North Carolina Supreme Court in support of funding the Leandro Comprehensive Remedial Plan which would increase educational opportunities for rural counties. The Leandro case was decided in 1997 when North Carolina was found NOT to be meeting its constitutional obligation to provide fair and equitable access to quality public education.
