The General Assembly did not convene for session over the past 2 weeks. So there are no votes or committee meetings to report.

NC Board of Science Tour



Last week I joined the [NC Department of Commerce](#) and other state legislators for the [NC Board of Science, Technology, and Innovation](#) quarterly meeting. The NCBSTI plays a key role in fulfilling the directives of Governor Cooper's [Executive Order 80](#), NC's Commitment to Address Climate Change and Transition to a Clean Economy, and the bipartisan HB951, which the GA passed last year. **By encouraging innovation, the Board keeps NC on the cutting edge of new climate change reduction technology**, so that NC will continue to be a player in the nation's team effort to address the seemingly insurmountable challenge of climate change. **I gave remarks in support of clean energy innovation across North Carolina** and the Board's and Governor Cooper's leadership.

I also learned more about the [One North Carolina Small Business Program](#) and heard a presentation from one of the grantees. If you are starting an innovative small business in NC, I encourage you to apply for a grant from the One North Carolina Small Business Program.

Breaking News on Abortion Rights in NC



This week brought bad news for people who expect the courts to protect constitutional rights. A federal district judge reopened a NC case, even though neither party asked him to, and lifted a permanent injunction on Wednesday. **This immediately changes NC abortion law**, which had protected abortion access up to the point of fetal viability per *Roe*. These changes mean abortion is banned after 20 weeks regardless of the circumstances, except in very limited cases that qualify as a medical emergency.

My bill, [SB888](#), would codify the protections of *Roe* into NC law so arbitrary bans like this would be blocked. You can read more about the decision [here](#).


Veterans Services Open House


Extracurricular and Volunteer Opportunities for Teens at Charlotte-Mecklenburg Library

State Funding for Electric Buses in Mecklenburg County



NC DEQ announced the Transit and Shuttle Bus Program grant recipients this week. These grants, funded with \$13.5 million from the N.C. Volkswagen Settlement and \$6.3 million in additional transportation funds, will help communities across the state reduce nitrogen oxides emissions by replacing older buses with cleaner, low-emission buses.

In Mecklenburg County, the grants provided \$4,385,164 to convert seven diesel CATS buses to electric. That means cleaner air for Mecklenburg County.

NC Firefighter Cancer Coverage Program



A \$15 million state fund for firefighters who have developed cancer while on the job has begun making payments. Firefighters with a new diagnoses qualify for a \$25,000 payment, followed by up to \$12,000 in reimbursements to cover out-of-pocket medical expenses. I am happy to see these important changes being implemented and am proud to have supported efforts to ensure firefighters receive this coverage they need and deserve. City of Charlotte Honored for Inclusivity Efforts



The City of Charlotte recently became a **Certified Welcoming place**. Welcoming America, a national nonprofit organization, bestows this recognition to local jurisdictions that have demonstrated their commitment to immigrant inclusion through their policies and programs. **The City of Charlotte is the first city in North Carolina and in the southeastern U.S. region to receive this designation.**

According to the 2020 U.S. census, 17.2 percent of Charlotte’s residents were born outside of the United States. As Charlotte-Mecklenburg’s immigrant population has grown over the last three decades, it is critical for inclusion to be a priority in our community. While the work of equity and inclusion never ends, achieving the Welcoming Place certification highlights the City of Charlotte’s commitment in this ongoing pursuit.

In order to become **#CertifiedWelcoming**, communities must meet rigorous requirements around matters including education, government leadership, safety, civic engagement, equitable access and more.

Free Pre-K for Eligible Mecklenburg County Kids



NC Laws for School Buses


North Carolina's law on stopping for a school bus

All traffic must stop for a stopped bus, unless it is on a road of four or more lanes with a median or center turning lane. In those instances, oncoming traffic does not have to stop because children will not be crossing the road to reach the bus. Traffic following a bus must always stop with the bus. If in doubt, always stop for a stopped bus.

COVID-19 & Monkeypox Updates



COVID-19 Updates:

The [DHHS COVID-19 Dashboard](#), which is updated weekly every Wednesday, shows the following data points:

- Wastewater testing has shown an **increase** to 28.2m particles, compared to 26.1m last week.
- COVID-like illness in hospital emergency departments **have decreased**, at 6.3% this week compared to 7.3% last week.
- COVID-19 reported cases for the week **decreased**, from 30,475 to 26,094.
- COVID-19 hospital admissions of COVID-19 patients this week **decreased** to 1,317, compared to last week which was at 1,354.
- Booster rates are 60% for the total population. We have 77% of adults with at least one dose and 30% of children and teens ages 5-17 with at least one dose.
- The Omicron variant continues to represent the vast majority of COVID diagnoses. BA.5 represents 73% of cases, BA.4 17%, BA.1.1.529 6%, BA.2.12.1 3%, and BA.2 less than 1%.

Monkeypox Updates:

Last week I attended a briefing from DHHS Secretary Kinsley after he visited a monkeypox vaccine clinic in Mecklenburg County. Some of the important information Secretary Kinsley and his team provided at the meeting:

- There are **important differences between monkeypox and COVID**. Monkeypox doesn't spread as easily and is rarely fatal. Unlike the early phases of COVID, with monkeypox, we have plenty of testing capacity and we already have a safe and effective vaccine. Unfortunately, access to the vaccine is still constrained as we are dependent on Denmark for supplies.
- **Anyone can get monkeypox**. It most commonly **spreads through close, prolonged skin-to-skin contact, often directly with a sore or lesion**. That could happen during sex, but also during cuddling, sharing a bed, or sharing linens with someone. The risk through brief touches: shaking hands, hugging, bumping into someone, or sharing space with someone in a public place is very low.
- **The main message is "if you have an unexplained rash, get tested as soon as possible."**
- Right now, **nearly all cases are among men who have sex with men**, but we will likely see cases spread to other communities. Viruses often take root in one group or community before spreading to others. Responding quickly and prioritizing the impacted community helps them immediately and helps everyone over time. So DHHS is focusing their outreach to the impacted community, including those at higher risk such as people who are on PrEP.

DHHS has established a [monkeypox website](#), which serves as an informational resource hub. Updates are made to this site frequently, included case counts and demographic data.


Monkeypox vaccines are free and available in Mecklenburg County, but currently in limited quantities. If you are experiencing symptoms or believe you have been exposed, contact your doctor or local health department to get tested. In Mecklenburg, that number is 980-314-9400.
