## NC Senate District 41 Newsletter

**December 16, 2022**

The General Assembly did not convene for session over the past two weeks. So there are no votes or committee meetings to report. This will be the last newsletter of the year, I hope everyone has a happy and safe holiday season.



## Election Litigation Updates



There has been significant court activity relating to North Carolina elections in the past week or so. The United States Supreme Court heard oral arguments for ***Moore v. Harper***, a case that could vastly change the way Americans vote and how candidates are chosen for office. This case, which was brought by North Carolina Republican legislators, will decide whether State Supreme Courts have a role to play in determining whether election maps are constitutional and how elections are conducted. I am deeply concerned about this case and am following it closely. You can read more about the case [here](#).

And today, the North Carolina Supreme Court issued its opinions in the ***Harper v. Hall*** and ***Holmes v. Moore*** cases. In *Harper*, the Court held that the 2022 State Senate district map is unconstitutional due to extreme partisan gerrymandering and must be redrawn with oversight by the trial court. It's unclear at this time whether the trial court will order legislators to redraw the map and, if so, when. In *Holmes*, the Court held that the 2018 voter ID law (**SB824**) is unconstitutional because it was "formulated with an impermissible intent to discriminate against African-American voters." The Court held, "the right to vote is a fundamental right, preservative of all other rights."

So, once again, State Senate district maps must be redrawn to be constitutionally compliant and legislators will need to try again to draft a voter ID law that allows the right to "exercise the franchise in a free and unimpaired manner."

### Potential Changes to NC's Education System



For the past year, the [House Select Committee on an Education System for North Carolina's Future](#) has been meeting to **discuss various changes to our education system -- from teacher pay to learning loss to standardized tests.** They recently announced their proposed recommendations, which include sweeping structural changes to teacher and principal compensation, job descriptions, testing, the school calendar, student discipline, and more. Rep. Torbett, the Chair of the committee, recently had an interview with EdNC about their recommendations -- you can read the article [here](#).

NC's Department of Public Instruction has also announced a **proposed pilot program to pay teachers based on outcome/student success instead of longevity.** This plan is still in its initial phases, and I expect a lot of debate on this topic when the General Assembly reconvenes in January. ### Meeting with Best Friends Animal Society



This week my staff and I met with two representatives from [Best Friends Animal Society](#). Their mission is to bring about a time when there are no more homeless pets by working to end kill-shelters and build community partnerships. We discussed **recommended changes to NC law to protect people who have pets during the rental process and to protect adoptable animals from being euthanized**. Unfortunately, North Carolina is the third-highest state in the nation for euthanizing stray animals. I plan to introduce legislation to improve how our state treats animals.

### Letter in Support of DACA Recipients



I was proud to sign onto a letter in support of DACA recipients, who have been waiting for years for permanent and lasting protections. The letter calls on Senators Burr and Tillis to lead the way to enact permanent protections for Dreamers. While state legislatures do not set immigration policy, I wanted to use this opportunity to express my support for DACA recipients.

## Meeting with NC Council on Developmental Disabilities



I met with the folks at the [NC Council on Developmental Disabilities](#) this week to learn more about the state's [Olmstead Plan](#), whose goal is to ensure we are providing support for people with disabilities. We discussed the current litigation related to folks with intellectual and developmental disabilities, including the recent ruling that North Carolina must provide services to people with IDDs in the home settings of their choice. ## Letter in Support of Protecting Endangered Species



I was proud to join the [National Caucus of Environmental Legislators](#) to sign a letter urging the U.S. House of Representatives and Senate to establish dedicated funding for states, territories, and tribes to **protect and recover endangered and threatened species** at the sub-national level. State fish and wildlife agencies have identified more than [12,000 species](#) that may become extinct unless there is human intervention. These species' risk of extinction is projected to increase as the threats of climate change and habitat loss are exacerbated.

## Made in NC Holiday Gift Guide





## COVID-19 Updates



Most children 6 months to 4 years are [now eligible for their updated COVID-19 vaccine](#), which protects against COVID-19 variants. These vaccine doses are becoming available in North Carolina this week following the Food and Drug Administration's emergency use authorization and the [Centers for Disease Control and Prevention's recommendation](#).

Children 6 months and older may be able to get this updated COVID-19 dose along with other routine vaccines at the same visit. Parents should talk with a health care provider to make sure their child is up to date on COVID-19 and other vaccines. The COVID-19 vaccine is safe to take alongside the annual flu shot.

You can see updates on the key data points (wastewater testing, hospitalization, vaccine rates, etc.) on the [DHHS COVID-19 Dashboard](#). I highly encourage everyone make sure they are up to date on the COVID-19 and flu vaccines for the holiday season.


