

### Save the Date: Town Hall in Huntersville on March 23



Join me for my second town hall of the year on **Thursday, March 23rd at 6PM**. This will be an in-person event at North County Regional Library (16500 Holly Crest Lane, Huntersville) with an option to join virtually as well. You can sign up at [this link](#). I'll provide updates about my legislative priorities for the biennium, my committee work, bills moving through the NCGA, and what issues are being debated in Raleigh.

### Updates on Noteworthy Votes



**Key bills on which I voted YES:**

- **HB76, Access to Healthcare Options.** An act to expand Medicaid in North Carolina. I've been advocating for this important step for a very long time and was proud and grateful to finally bipartisan support for this vitally important piece of legislation. It will save lives, save rural hospitals, boost our economy, avoid medical bankruptcies and more.
- **HR175, Confirm Ed Wilson/Special Superior Court Judge\***. Approve confirmation of Ed Wilson as Special Superior Court Judge per Governor's Cooper's recommendation.
- **SB58, Protect Critical Infrastructure\***. Increases punishment for attacks committed against utilities. This bill was passed in response to the attack on Moore County's critical infrastructure.
- **SB156, Medicaid Children & Families Specialty Plan.** Ensures that children in foster care maintain Medicaid-covered health services if they are moved to another county. I am proud to be a co-sponsor on this important bill.
- **SB189, Fentanyl Drug Offenses and Related Changes\***. Increases the fine amounts related to trafficking heroin, fentanyl and other dangerous street drugs, provides for new offenses related to deaths caused by the distribution of certain controlled substances, and establishes the Task Force on Enforcement of Fentanyl and Heroin Drug Violations.
- **SJR54, Confirm Katherine Bosken, Commissioner of Banks\***. I was happy to vote yes on confirming Katherine Bosken as the Commissioner of Banks and appreciated her taking the time to explain why she is confident about the safety and security of North Carolina's banks, which are structured very differently than the banks that failed in other states earlier this week.

**Key bills on which I voted NO:**

- **HB40, Prevent Rioting and Civil Disorder.** Increases penalties for current offenses and creates new offenses related to civil disorder that occurs in conjunction with protests. This bill is unnecessary since rioting and property damage is already a crime. I oppose it because it casts an unconstitutional, wide net that will punish non-violent protestors and will have a chilling effect on North Carolinians first amendment rights to peacefully protest. I introduced an amendment on this bill to align it with the First Amendment freedom of speech protections, but Republicans voted down the amendment. The bill passed both chambers and, although the Governor Cooper vetoed the bill in 2021, he declined to veto it this year. You can read about that [here](#).
- **HB88, Omnibus Local Elections.** Changes the way vacancies on the Guilford County Board of Education will be filled. It arose out of a push by the local GOP executive committee to appoint a controversial nominee for a vacant seat and the Board's refusal to seat him. You can read more about the bill [here](#). The bill also makes the following counties change their Board of Education races from non-partisan to partisan: Ashe, Cabarrus, Henderson McDowell, and Mitchell. I received many emails opposing the politicization of school boards.
- **SB157, Limited Provisional License Modification.** Permanently reduces the time a limited learner's permit must be held before obtaining a provisional license from one year to nine months. While I agree that we need to do more to assist young drivers who are still facing serious backlogs due to the pandemic, I do not agree with this total overhaul of the learner's permit process. I fear it will make our roads more dangerous and cause injury and teen driver collisions.

## Introduced & Co-Sponsored Bills



These are the bills I have introduced and co-sponsored in the past 2 weeks. You can find a full list of the bills I have supported [here](#). All local bills (for North Meck towns and CMS) were filed per their respective requests.

**Introduced bills:**

- [\*\*SB210, Gun Violence Prevention Act.\*\*](#) A comprehensive omnibus gun safety bill, whose highlights include universal background checks, mandating safe storage, banning bump stocks, and prohibiting semiautomatic weapons for those under 21. - [\*\*SB227, Funds for Davidson Pedestrian Safety\\*\*\*](#). Appropriates \$600,000 to improve pedestrian safety in the Town of Davidson. You can read WSOC-TVs coverage of this bipartisan bill [here](#).
- [\*\*SB229, School Calendar Flexibility/CMS.\*\*](#) Provides flexibility to the Charlotte-Mecklenburg Board of Education in adopting the school calendar.
- [\*\*SB231, NC Adopt ERA.\*\*](#) Ratifies the Equal Rights Amendment to the US Constitution to enshrine equal rights for women. I am proud that this important bill is co-sponsored by every House and Senate Democrat. Unfortunately, no bipartisan support.
- [\*\*SB241, Design Element Exemption-Historic Downtown Davidson.\*\*](#) Allows certain design and aesthetic controls for structures located along Highway 115 in the historic downtown of Davidson.
- [\*\*SB242, Davidson/Demolition of Historic Structures.\*\*](#) Authorizes Davidson to adopt ordinances regulating the demolition of historic structures.
- [\*\*SB243, Town of Davidson-Expedited Review.\*\*](#) Clarifies that the Davidson is not required to provide expedited review of certain subdivision approvals.
- [\*\*SB264, Davidson Historic District Subdivision Exemption.\*\*](#) Exempts designated historic districts from certain restrictions on zoning in Davidson.
- [\*\*SB270, Funds for Cornelius Infrastructure Projects.\\*\*\*](#) Appropriates \$1 million to the Town of Cornelius for infrastructure improvements in Smithville.
- [\*\*SB271, Funds for Cornelius History Museum.\\*\*\*](#) Appropriates \$3 million to acquire and restore the historic Cornelius High School agriculture building to serve as a history museum in Cornelius.
- [\*\*SB272, Funds for Smithville CommUNITY Coalition.\\*\*\*](#) Appropriates \$3 million for the Smithville CommUNITY Coalition for the protection of the historically African American neighborhood in Cornelius.
- [\*\*SB285, Request Consent/Early Voting/Charlotte-Mecklenburg Schools.\*\*](#) Requires consent from the CMS Superintendent before using certain schools as early one-stop voting sites to ensure student safety.
- [\*\*SB306, Fix Our Democracy.\*\*](#) An **omnibus elections and voting rights bill** to end gerrymandering, secure fair courts, increase voter accessibility, ensure more transparency in the legislature, and implement campaign finance reforms.
- [\*\*SB328, Improve Pipeline Safety.\*\*](#) A bill filed in response to the Colonial Pipeline leak in Huntersville. It seeks to protect North Carolinians and our environment from aging and poorly maintained pipelines by providing increased authority to DEQ to study and maintain pipelines and directs DEQ to report findings to the Joint Legislative Commission on Energy Policy.

**Co-sponsored bills:**

- [\*\*SB226, Freedom to Vote.\*\*](#) Appropriates funds to the State Board of Elections for election security, prohibits voter and poll worker intimidation, improves voting access, expands one-stop early voting, and studies creating a nonpartisan process for redistricting. - [\*\*SB256, Harmony Requirement Changes - Town of Huntersville.\\*\*\*](#) Clarifies the harmony requirement limitation for residential developments that contain affordable housing for the Town of Huntersville. Filed per town request.
- [\*\*SB263, Healthy Students - A Nurse in Every School.\\*\*\*](#) Requires at least one school nurse in every school in a public school unit beginning in the 2023-2024 school year.
- [\*\*SB288, Increase Rates/Set Floor/Child Care Subsidy.\\*\*\*](#) Increases child care subsidy rates to those in the 2021 market rate study, with automatic increases upon completion of subsequent new studies.
- [\*\*SB294, Reduce Maternal Morbidity/Mortality/Medicaid\\*.\*\*](#) Implements rate increases for obstetrics maternal bundle payments for pregnancy care.
- [\*\*SB295, Student Tax Reduction \(STAR\) Act\\*.\*\*](#) Eliminates the tax burden on student debt relief.
- [\*\*SB320, Honoring NC's Contribution to Civil Rights.\*\*](#) Authorizes the African American Heritage Commission to study the feasibility of establishing monuments commemorating events and persons related to the Civil Rights Movement in the state and appropriates funds to place markers at sites along NC's Civil Rights Trail.
- [\*\*SB330, Protect Judges' Personal Information.\\*\*\*](#) Protects the personal information of judges and their immediate family members.

## Press Conferences at the NCGA

It has been a very busy two weeks in Raleigh. I held numerous press conferences with Senate and House colleagues and advocates to announce bills we filed to address various causes about which I am passionate.

I joined gun safety advocates and survivors of gun violence at a moving press conference on my Gun Violence Prevention Act bill and other commonsense gun safety reform bills filed by my colleagues.

We marked International Women's Day with a press conference about the importance of passing the ERA!

## DEQ Public Hearing on Proposed Wastewater Permit



Yesterday I joined Huntersville residents and environmental advocates for **DEQ's public hearing on the proposed wastewater permit for the Colonial Pipeline leak**. I was happy the event was well attended by residents, elected officials and numerous press outlets. As I said at the event, the residents whose lives have been disrupted by this massive leak near their homes deserve to have their questions answered and to know that **water will be safe before its released into the nearby creek**. The Yadkin Riverkeeper and the Southern Environmental Law Center argued that the permit must be strengthened to meet safe standards for benzene per the Clean Water Act and that the effluent should be monitored for PFAS too. This impacts not just Huntersville residents, but everyone downstream too. You can read more about the hearing [here](#).

On a related note, I also re-filed **SB328, Improve Pipeline Safety**, yesterday which would ensure that there is more transparency and accountability for our aging hazardous liquid pipelines so that we can avoid allowing something like this to happen again.

## Appropriations/Base Budget Committee Updates



The [\*\*House and Senate Appropriations/Base Budget Committees\*\*](#) met for a joint meeting this week to hear a presentation of the Governor's proposed budget. The budget proposal includes an **average 18% teacher raise over the biennium, a \$1 billion plan to support mental health, the largest investment in state employee compensation in 50 years and critical funding for childcare, job training, and economic development**. This is a responsible, balanced budget that does not raise taxes for North Carolinians while maintaining almost \$7 billion in reserves in case of a potential downturn. Budget negotiations will begin in full in the coming weeks and months. Republicans in the NC House have not presented their budget yet. Keep an eye on my social media and future newsletters for budget updates.

## Education Committee Updates



The following noteworthy bills were discussed in the [Senate Education Committee](#) over the past 2 weeks:

- [HB11, Schools for the Deaf and Blind](#). Would change the governing structure of the Eastern NC School for the Deaf, the NC School for the Deaf, and the Governor Morehead School for the Blind to be by separate Boards of Trustees and would remove the Governor's appointment powers. I do not support this bill because it is unconstitutional violation of the separation of powers.
- [SB90, Searches of Student's Person](#). Standardizes the procedures for searching students' bodies in public schools. The initial version of this bill was egregiously unconstitutional, but the sponsors changed the language during the committee hearing to comply with the 4th Amendment protections against unreasonable search and seizure.
- [SB187, Teacher Licensure/Retired Educator Program](#). Makes changes to teacher licensure requirements and expands the program to allow retired educators to return to work in high-need schools.
- [SB193, Career Development Plans](#). Provides for career development plans for all middle and high school students. I am proud to be a **co-sponsor** of this bill.
- [SB239, Reduce Barriers to State Employment](#). Reduces barriers to state employment by directing the State Human Resources Commission to regularly assess education, experiential, and training requirements for state jobs.

We expect all of these bills to make their way through Senate committees and to the floor for a vote soon. So if you have feedback about them, let me know.

## Ocular Melanoma Research



Staff from the [NC Collaboratory](#) recently contacted my office to provide an update on the **gene therapy related ocular melanoma research project**. The project is just now entering the second half of its first year and will continue to receive guaranteed funding through June 2024.

By the end of the research project the team hopes to have generated a “playbook” for the development of AAV-based **drugs for the treatment of uveal melanoma**. Further research would include experiments to develop an arsenal of AAV-based vectors that target additional genetic defects in uveal melanoma, such as tumor suppressor mutations and regulatory RNA molecules. **If you'd like more information about this research, let us know and I can share the full update.**

## Senator Marcus in the Community & Meetings in Raleigh



The Joint Legislative Women's Caucus met for the first time this biennium at the NC Museum of Science. I was there, but missed the photo. It's good for female legislators to meet in a bipartisan environment. We discussed a bill to require 3D mammograms to be covered by insurance.



The Mecklenburg Delegation visited Central Piedmont Community College to discuss the school's legislative priorities for the 2023 Legislative Session with Dr. Deitemeyer and members of the Board of Trustees.



I met with members of the Chapel of Christ the King Church for the Episcopal Diocese of NC for their advocacy day. We discussed affordable housing initiatives, climate change action, and gun violence prevention.



I had a Zoom meeting with two Northwest School of the Arts students because they wanted to present their AP course project advocating for laws to protect the right of same-sex couples to marry and adopt children, per *Obergefell v. Hodges*, in a post-*Dobbs* environment.



Earlier this week Governor Cooper announced a violence prevention initiative in conjunction with the Attorney General's office. I was happy to attend the announcement at the Governor's Mansion, along with many violence prevention advocates, including some from Mecklenburg County. Read more [here](#).


