Dr. Claxton will present **Community Action: Section 8 and Other Programs to Support Low-Income Communities** on Wednesday afternoon.



**Details:** HUD provides a wide range of programs and services related to housing for citizens. Through programs like the Housing Choice Voucher Program (Section 8) they assist low-income families in securing stable housing.

Many community action agencies work with this program to better serve their local communities, but there are other programs and services HUD offers that serve seniors, veterans, and those struggling with homelessness.

### Important Medical Note

#### Proof of full COVID-19 Vaccination is required for all in-person attendees at the conference.

Exceptions will be made for those who cannot receive the vaccine due to medical conditions only. If you have a medical condition that prohibits you from receiving the vaccine, a letter from a physician on their letterhead must be provided. Details on the individual condition are not required, but the letter must be from a physician that you are unable to receive the vaccine due to medical issues. Also, those with the medical exception will be required to provide proof of a negative test no older than 72 hours prior to arrival.
