BREAKING NEWS: Abortion Ban Passes in North Carolina House and Senate on Party Line Vote



Yesterday was historic. My Senate Democratic colleagues and I used every procedural, persuasive, and legal tool we had to fight the **dangerous abortion ban, SB20**. We used every rule, motion, appeal and allotted minute to speak that we had available. We started at 10 am and finished after 5 pm. We felt strongly that the bill will severely restrict access to abortion care, drive OB/GYN doctors out of our state, and tell NC women that our government doesn't trust us to make decisions for ourselves. It was a dark day for women's rights. Media outlets around the nation, including the NYT, WSJ and MSNBC, covered the longest floor debate in the Senate Chamber and the fact that the abortion ban is **worse than you think**.

As expected, we didn't have the votes to defeat SB20. Governor Cooper said he will veto this dangerous bill. Given the Republican supermajority, it is unlikely to be upheld. Stay tuned for updates.

Below are a few noteworthy bills I voted on over the past two weeks. You can find a full list of bills I voted on [here](#).

Key bills on which I voted YES:

- **[SB321](#), [Medical Debt De-Weaponization Act](#).** * Limits ability of large medical facilities to charge unreasonable interest rates and employ unfair tactics in debt collection and limits ability of non-hospital health care facilities to charge "facility fees."
- **[SB326](#), [Firefighter Cancer Insurance/Alternative Criminal Record Check](#).** * Makes the Firefighters' Health Benefits Pilot Program permanent and allows county clerks of court to conduct criminal background checks on certain fire-fighting and prevention services applicants.
- **[SB339](#), [Modify Limited Driving Privilege/Criminal Law](#).** * Bipartisan bill that modifies the statutory provisions affecting limited driving privileges and prohibits the impersonation of taxicab drivers.
- **[SB360](#), [Modify Victim and Sex Offense Registry Laws](#).** * Bipartisan bill that modifies the laws protecting and aiding victims of crime and clarifies certain registration processes of the NC Sex Offense Registry.
- **[SB376](#), [Expanding Members' Access to HOA Records](#).** * Addresses property owners' desire to have ways to hold their HOA accountable and encourage transparency.
- **[SB542](#), [DOL/Omnibus Law Changes Agency Bill](#).** * Requires employers to keep accurate records to provide evidence of when overtime wages are due and makes other changes per Department of Labor recommendations.
- **[SB565](#), [Remove Barriers to Jobs and Housing](#).** * I am proud to be a co-sponsor of this bipartisan bill that improves the Second Chance Act by revising the laws governing automatic expunctions.
- **[SB574](#), [Authorize NIL Agency Contracts](#).** * Authorizes NIL contracts for college athletes and exempts them from public records requirements.
- **[SB579](#), [Prevent Harm to Children](#).** Protects children from being subjected to obscenity, as it is currently defined under NC law, by increasing the penalty for doing so. Democrats offered [an amendment](#) to 1) update the law to modern standards with understanding that technology provides access to obscenity in ways that were not available when the original law was passed, and 2) establish a Prevent Harm to Children Taskforce. It would have made the bill better, but the amendment was tabled. You can read more about the bill [here](#). Notable point: the bill does not change the definition of obscenity or target or mention child shows.
- **[SB625](#), [Child Welfare, Safety and Permanency Reform](#).** * Comprehensive child welfare bill that makes long overdue bipartisan-endorsed changes to our child welfare, foster, and adoption systems which will help our state's most vulnerable children.
- **[SB626](#), [Modify Laws Related to Human Trafficking](#).** * Comprehensive anti-human trafficking bill per recommendations from the [NC Human Trafficking Commission](#). Creates a right of victims to seek a lifetime no-contact order against their trafficker, expands the crime to include patronizing and soliciting to address the demand side of the problem, and allows victims to collect compensation even if they commit a misdemeanor if done at the behest of their trafficker.
- **[SB640](#), [Various Criminal Procedure Changes](#).** * Helps law enforcement solve crimes by requiring sharing of matches on CODIS, a software database of DNA profiles of convicted offenders, unsolved crime scene evidence, and missing persons.
- **[SB650](#), [Gun Violence Prevention Act](#).** * Increases the criminal penalty for possession of a firearm while committing a felony. I am disappointed that my bill, [SB210](#), also named the Gun Violence Prevention Act, did not receive a vote as it is a much more comprehensive approach to curbing gun violence. I introduced 4 commonsense amendments with broad bipartisan support to strengthen SB650 ([mandate universal background checks](#), [implement red flag laws](#), [prohibit assault weapon sales to those under 21](#), [require safe storage of firearms](#)), but they were all tabled.
- **[SB678](#), [Promote Clean Energy](#).** * Omnibus clean energy bill that includes nuclear as an option to reach our carbon neutral climate change remediation goals.
- **[SB722](#), [Child Care Flexibilities](#).** * Addresses workforce shortages in early childhood facilities by changing certain credential requirements.

Key bills on which I voted NO:

- **[SB20](#), [Care for Women, Children, and Families Act](#).** Dangerous abortion ban bill, full details in section above.
- **[SB319](#), [Captive Insurance Provisions](#).** Creates a special tax carve out for out-of-state captive insurance companies. I believe they should have to pay the same tax as NC-based companies.
- **[SB329](#), [Retail Installment Sales Act Amendments](#).** Raises the rates on consumer credit installment sales contracts (i.e. appliances and cars), which will increase costs for working families across the state.
- **[SB364](#), [Nondiscrimination & Dignity in State Work](#).** An unnecessary, poorly drafted bill that is motivated by the sponsor's desire to fight "wokeism" and is based on his belief that state agencies should not hire, promote and train employees in equality,

diversity and inclusion concepts. Bill sponsors refused to accept [an amendment](#) from Sen. Chaudhuri that would have implemented paid parental and sick leave and put an insurrectionist from being government employees.

- [SB508, Remove Volunteer Chaplain Education Requirements](#). The Department of Corrections opposes the bill due to the security risks of allowing anyone to enter prisons as a chaplain. Prison chaplains should be required to show minimum credentials in order to be granted the access to prisoners that is afforded to chaplains.
- [SB582, North Carolina Farm Act of 2023](#). Comprehensive omnibus agriculture bill. I voted no because 1) it will remove important state protections for wetlands, thereby increasing the likelihood of flooding and state expenses related to flooding, 2) it allows hog farmers to burn biogas without sufficient provisions to protect air quality, and 3) it does not provide any support for small and minority farmers, despite [an amendment](#) Democrats offered to include such funding.
- [SB737, Address ESG Factors](#). Addresses use of environmental, social, and governance criteria (ESG) by state agencies and state pension plan fiduciaries. I do not support this bill because we need to ensure that our investment funds are sound and stable, and prohibiting ESGs does not do that.

Rental Assistance for Eligible Cornelius Seniors



The Cornelius Community Development Corporation (CDC) will be administering a **one-time senior rental assistance program**. It will be limited to seniors living in the Town of Cornelius, and the maximum allowance will be half of any proposed rent increase, up to \$200/month per rental unit.

Seniors will be required to submit applications which show they have experienced a rent increase of at least 15%. Applicants must also show proof of total earnings of 70% of Area Median Income (AMI) or below. Applicants for senior rent relief must be single or married households of persons 55+ on fixed income not employed.

E2D Hosting Laptop Distribution Event



E2D, a Davidson-based nonprofit, has launched a **monthly laptop distribution event** called "Tech Tuesday". All distributions are on a first come first serve basis. Laptops cost \$80 each if paying with cash or money order; \$84 each if paying with a card. They have a maximum of 2 per family/household. The next event will be at 18605 Northline Drive in Cornelius from 3-5PM on May 16th.

Study on Juvenile Recidivism Rates



The North Carolina Sentencing and Policy Advisory Commission conducts biennial recidivism studies of juveniles in North Carolina and of the effectiveness of programs receiving Juvenile Crime Prevention Council grant funding in North Carolina. The study followed 5,822 juveniles with a delinquent complaint who exited the juvenile justice system in FY 2020 following diversion, probation, or commitment to a youth detention center. Of the 3,305 diverted juveniles, most (90%) successfully completed their diversion plan or contract. Juveniles with a successful diversion spent an average of 4 months in the juvenile justice system compared to an average of 3 months for those with an unsuccessful diversion. **Only 9% of diverted juveniles recidivated during their juvenile justice involvement.** You can read the full report [here](#).

COVID-19 Test & Vaccine Updates



NC DHHS is partnering with Project Act to provide **free COVID-19 tests to all North Carolinians**. This program used to just be available for select zip codes, but it is now available statewide. Order your free tests [here](#).

Additionally, DHHS has **approved additional booster shots for folks 65+ and/or who is at high risk for severe illness**. Anyone who meets the age requirement is eligible for a bivalent booster if it has been at least 4 months since their previous vaccine. Folks with compromised immune systems can get a booster if it has been at least 2 months since their last vaccine. More information [here](#).


The State Controller is North Carolina’s chief fiscal officer and serves as an independent resource to ensure the financial integrity of the State.
