

Editorial

The Politics of Privilege By Tarik Kiley 6/30/2023



First, America does need to stop using race in its politics. Second, if America does base its politics on race, as Americans, we still need anti-racist policy, to remedy the long-standing ill effects of existing racist policy.

Affirmative Action is a form of anti-racist policy. Believing that all Asian-Americans perform better in school than Black and Brown people, is a racist stereotype, albeit a positive stereotype. Asian Americans face poverty and hardship just like any other ethnic group, and there are outstanding Black and Brown people who have also contributed to this country in an outstanding academic manner.

Thurgood Marshall was such a good attorney that he ended up as a Supreme Court Justice, as an African American man, for example. So, while not all African Americans underperform in school, the number of obstacles that are put in the path of Black people as we are socialized into American society has been ridiculous, historically.

African Americans, who have lived in urban settings, more predominantly, since the Great Migration, have had our neighborhoods historically disinvested in, for example. There was deindustrialization, redlining, school segregation, restrictive covenants, Urban Renewal, and the demolishment of our neighborhoods under the false pretense of curing economic blight, job discrimination, and outright violence such as the assignation of our leaders, lynching, and hate crimes. Of course, it should also be noted that southern Blacks primarily suffered under Jim Crow laws, as well.



After all this hardship, Blacks have only sought equality, and have not asked for privilege. We just ask for equality. Affirmative Action was a step towards moving us towards this equality, particularly in higher education.

What is Affirmative Action? According to law.cornell.edu, "Affirmative action is defined as a set of procedures designed to;

eliminate unlawful discrimination among applicants, remedy the results of such prior discrimination, and prevent such discrimination in the future. Applicants may be seeking admission to an educational program or looking for professional employment. In modern American jurisprudence, it typically imposes remedies against discrimination on the basis of (at the very least) race, creed, color, and national origin." Nowhere does Affirmative Action advocate for the establishment of Black privilege in higher education. It only seeks to end White privilege in higher education.



The fact that some would sue to stop Black and Brown people from having opportunities to academically excel is a clear sign of some not wanting Black and Brown people to have any type of opportunity to compete in a fair world. For example, legacy admissions are not fair, and the level of wealth, prestige, and access that your family has, impacts the likelihood of you

getting into college, and especially an Ivy League one.

Racism exists—if not in policy, then in practice. So, the Supreme Court in striking down Affirmative Action in higher education, is a failure, because it has not been replaced by a commitment to end the racism, which called for Affirmative Action's necessity in the first place. More specifically, according to npr.org, "Supreme Court justices ruled that the admissions policies at the University of North Carolina, one of the country's oldest public universities, and Harvard University, the country's oldest private university, violated the equal protection clause of the 14th Amendment."

But, while calling anti-racism, racism, the fact remains that race is more likely to be used to exclude Black and Brown people from higher education, as opposed to be used to unfairly benefit us.

Npr.org goes on to say the following:




A quarter-century after California banned race-based admissions at public universities, school officials say they haven't been able to meet their diversity and equity goals — despite more than a half billion dollars

spent on outreach and alternative admissions standards.

In an amicus brief sent to the Supreme Court in support of Harvard and UNC's race-based admissions programs, University of California chancellors said that years of crafting alternative race-neutral policies have fallen short. "Those programs have enabled UC to make significant gains in its system-wide diversity,' the brief said. "Yet despite its extensive efforts, UC struggles to enroll a student body that is sufficiently racially diverse to attain the educational benefits of diversity." The shortfall is especially apparent at the system's most selective schools, the university leaders said.

It is no secret that the USA's most prestigious schools fail the diversity test. So, this is not about diversity and fairness. This is about privilege. If you live in a system designed to keep you poor and oppressed, and you wind up being poor and oppressed, then that system is working towards its intentional outcome of enforcing racism, and the resulting poverty and oppression.



Still, we must build a society where having darker colored skin is not stigmatized and used as a sign of some type of failed intellect. There are plenty of smart Black and Brown people in this world, and no one should be judged and stigmatized because they look a certain way.

Imagine if you walked into a classroom and automatically you were expected to fail, just because of your ethnicity?

Conversely, imagine if you were expected to succeed just because of your ethnicity? It is not that Asian students are just smarter than everyone else. It is possible though, that this image was cultivated, and encouraged, because it is a positive stereotype—yet it is still a stereotype.



Instead of encouraging stereotypes, we should be encouraging excellence for all students who show it. The Black kids shouldn't always have to feel like we must sit together in the

cafeteria at lunch. And believe it or not, Black kids shouldn't be made to feel like our aspirations for wealth, prestige, and academic excellent are somehow unattainable.



After all, it is completely unfair to put obstacles into one's path, and to have another running the same foot race, without an equal level of obstacles put into their path. How can you say you legitimately won a foot race, if you only won it because you handicapped all your opponents? So, with this metaphor, we must recognize that antiracist policy is still necessary.
