Bills Signed

Last Monday, the Governor signed the following bills into law:

- Senate Bill 722: Child Care Flexibilities.
- House Bill 203: DST Technical Corrections.-AB

Paid Leave

Proposed new state rules lay out how teachers and other North Carolina public school employees can take up to two months of paid parental leave after having a baby.

The state's new law limiting abortions also included a paid parental leave option for state employees, including those who work in public schools, the UNC System and community colleges. State lawmakers provided \$10 million to help cover the cost of hiring substitute teachers. The State Board of Education reviewed draft rules on Thursday that would put the new law, which went effect July 1, into practice.

School districts have been pressing for information on how to apply the law. The state board will vote on the rules and changes to state policies in August.

I believe this new law is a good way to provide new families the flexibility to be home longer to bond as a family.

HBCU Enrollment

The U.S. Supreme Court's ruling on affirmative action is starting conversations at Historically Black Colleges & Universities across the country. Supreme Court justices set new limits on affirmative action, striking down the current race-conscious admissions policies in place at the University of North Carolina and Harvard University.

At least 50% of Black teachers in this country are educated at HBCUs. Many universities anticipates enrollment increases following the affirmative action ruling.

I am disappointed in this new ruling. For years affirmative action has helped marginalized students get into colleges that they would not have because of their race. I believe we should be able to attend the college of our choice.
