Charlotte Pride Festival & Parade to Host a Record Number of LGBTQ+ Allied Organizations

The Charlotte Pride Festival and Parade will return to the streets of Uptown Charlotte later this month from August 19-20. This year marks more than 20 years of Charlotte Pride and more than 40 years of Pride legacy in the Queen City.

The League of Women Voters of Charlotte Mecklenburg will once again participate in this important event to show support for our LGBTQ+ community by hosting a voter registration and education booth both days and marching in the parade on Sunday, August 20.

Leaguers interested in registering and educating voters at the booth may sign up for 2-hour time slots using [Sign Up Genius here](#). There are still slots remaining for both days. Volunteers must be League members to register voters. The booth will be stocked with LWV giveaways, membership brochures, voter registration forms, general election information, details about this year's election law changes, Voter ID information and our "What's on Your Ballot" primer. 

LWVCM Education Team Facilitates CMS Listening Session on 2029 Strategic Plan

The LWVCM Education Action Team worked with the Charlotte Mecklenburg Schools Board of Education to engage community members and education advocates in a Listening Session. The Education Team reached out to 23 community allied organizations to encourage them to provide information about the event to their members.

The CMS Listening Session was held on July 27 at the Charlotte-Mecklenburg Government Center with a total of 34 people participating in the session which was held in-person and online.

Two CMS School Board candidates Liz Monterrey and Monty Witherspoon, and a candidate for NC House Representative Lisa Jewell (District 98) attended the session.

Jennifer De La Jara, Summer Nunn, and Lenora Shipp, CMS Board members, asked participants to respond to questions related to “what they hoped students would know and be able to do by the end of elementary, middle and high school.” Additionally, participants were invited to share their thoughts on “what our school system is doing well and what they are not doing well.” A good discussion ensued with some of the most vocal respondents being teachers. Responses were recorded and the CMS School Board will consider them as they develop new goals and guidelines.

Several League Public Education allied organizations had a representative in attendance including the NC Black Child Development Institute, Communities in Schools, MeckMin and MeckEd.

Five more Student Outcomes Focused Governance (SOFG) Listening Sessions will be held during the next two weeks. See the [CMS calendar](#) for details.

School Board Member De La Jara says, “the viewpoints and ideas expressed by participants are invaluable to the BOE as it embarks on reevaluating its Goals and Guardrails, the metrics by which the Board evaluates itself and the Superintendent. The BOE will be hosting another SOFG workshop on Saturday Aug 19 at the Government Center, which is open to the public and will also be live streamed. This is the next step in the process of synthesizing the collective community feedback and working alongside the Superintendent to develop CMS’s next strategic plan. A heartfelt thank you to the League of Women Voters and your community partners for sharing your vision and values with us.”

Women’s Equality Day Commemorated by the LWVCM in Special Video Presentation

On August 26, the day the LWV now refers to as Women’s (In)Equality Day, members of the League of Women Voters of Charlotte Mecklenburg will receive access to a special video presentation narrated by Suzanne Elsberry, featuring abolitionist and American hero Harriet Tubman as portrayed by member DonnaMarie Woodson.

The presentation is an excerpted version of a script written by Mary Lou Bennett of the LWV-Moore County. We both acknowledge and thank her for permission to adapt one of her scripts from “Lunch with Legends,” her annual series that has been running for 15 years.

An Organizational Assessment of Our League Chapter Is Underway

The LWVCM has embarked on a guided organizational assessment to identify key areas for improvement, growth and best practices/principles. This systematic review is being conducted with the help of a consultant from Executive Service Corps of the Triangle (ESC) based in Durham. ESC conducted a similar, successful review for LWV-Wake County.

Moral Monday Comes to Charlotte

Several members of the LWVCM Education and Voter Service Teams participated in the Moral Monday rally on June 24 in Uptown Charlotte. Many concerned citizens came out to support the Poor People’s Campaign event titled “Wake the Sleeping Giant”. Reverend Dr. William J. Barber made an appearance to the delight of the crowd gathered at the Charlotte-Mecklenburg Government Center. Preserving Our Fundamental Right: The Right to Vote

"The right to vote is a fundamental right, preservative of all other rights. If the right to vote is undermined, it renders illusory all 'other rights, even the most basic' ..."

—Justice Anita Earls, Associate Justice of the Supreme Court of North Carolina

Ideally, our state government should be about assuring its citizens easy access to the ballot box versus placing impediments to their constitutionally guaranteed right to vote. The League supports free, fair and accessible elections for all eligible Americans, and strongly opposes the creation of obstacles preventing full participation in our democratic processes.

Following the reversal of the North Carolina Supreme Court's declaration that the requirement of voter photo identification is unconstitutional, voters in our state will once again be asked to show "acceptable Photo ID" to cast a ballot. The new voting law will commence with the September 12 Primary Election for the City of Charlotte. Absent this identification, in-person voters are required to complete a form showing a "reasonable impediment" to submit a provisional ballot (counted only if the form is deemed accurately completed.) Voting by mail also requires the enclosure of an ID photocopy or the completion of an exception form.

The implementation of this new law is a costly and unnecessary attempt to address the nearly non-existent problem of voter impersonation. For example, in 2016 there was 0.00002% credible instances of in-person voter fraud in our state translating to one fraudulent vote out of nearly 4.8 million cast. This solution in search of a problem will doubtless lead to the potential disenfranchisement of tens of thousands of citizens, the majority of whom, according to recent studies, are eligible rural and minority voters.

The League is working to ensure voters will have the necessary information about changes in the voting process in advance of the upcoming elections. Please go to www.Vote411.org and the North Carolina State Board of Elections website (ncsbe.gov*) to obtain up-to-date comprehensive information on all aspects of voting.

Voting is the most basic democratic right of Americans to exercise an equal voice in the way in which they are governed. Any barriers to this constitutional guarantee pose a dire threat to our democracy.

As we begin our fiscal year and move into our 104th anniversary, I thank our new Board, Action Team Leaders, members, donors and partners for their invaluable contributions helping to make us the strong and robust organization of today. Our membership roster has continued to grow over the years from 153 members in 2017 to our current number approaching 280! I urge you to invite friends, co-workers and relatives to join the League and help us in our mission to empower the vote and defend democracy!

Op-Ed: “Democracy Straining to Survive” by Harry Taylor

Despite the normal once-per-decade election map redrawing for U.S. House, N.C. Senate/House, all will be reconfigured prior to 2024 elections. Legal decisions and the state supreme court swing to GOP control in 2022 opened the flood gates for the legislature to make generous use of severe gerrymanders across the board. A tactic used by both parties over the years.

Expect U.S. House seat distribution to change from current 7-7 to 10-4 or 11-3 in favor of the GOP. State senate and house maps will further cement the Republican's super-majorities. Coupled with the openly partisan state justice system, there will be no avenue to force map reconfigurations through the courts. The sole exception could occur if map-drawers trip up and create districts that disadvantage minorities.

Of concern, the U.S. Supreme Court (SCOTUS) ruled that Alabama must redraw Congressional maps to create a second minority district. That state legislature thumbed its nose at the court, and redrew the maps without that district. Across the country, we see GOP controlled legislatures defying state and federal constitutions, state courts, and even SCOTUS.

All this chaos to suppress voting and rig elections is straining our democracy, a strain not confined to the U.S. Italy, Brazil, Venezuela, Hungary, and now Israel no longer operate as democracies. One of our two political parties has been “going to school” on those disasters. Enthralled with Hungary's Prime Minister Viktor Orbán's *illiberal democracy*, the Conservative Political Action Committee (CPAC) has twice traveled to Budapest to hear Orbán share how to achieve such electoral success. How does that go over with Hungarians? Take a moment to read [It happened there: How Democracy Died in Hungary](#). Former parliament member Zsuzsanna Szélenyi says “Hungary is not a democracy anymore; parliament is a decoration for a one-party state. Most observers **didn't understand what Orbán was up to until it was too late**. He benefited from the supermajority so quickly that no one really realized” what had happened.

If “until it was too late” prompts a double take...yes...that's an apt observation of how most of America is treating these non-stop threats to democracy.

League Leadership Interviewed for Sharon View Place Resident Human Interest Project

Sharon View Place residents Suzanne Elsberry and Margaret Howe-Soper share more than just a neighborhood. They share a passion for politics and volunteering with the League of Women Voters of Charlotte Mecklenburg.

Suzanne joined in 2012 after relocating to Charlotte. She has been president of the Charlotte Mecklenburg chapter since June 2021. "I am involved with the League 24/7," says Suzanne. "I just love it. I am a people-person and I have always been very interested in politics."

The LWV is committed to protecting and expanding voting rights and to ensuring everyone is represented in our democracy. "The league is nonpartisan," says Suzanne. "And we are very careful not to endorse candidates or political parties. Our goal is to educate and advocate for voters."

One educational offering is Civics 101, six once-a-week classes led by current and former government officials and local media. The sessions cover the Mecklenburg County Board of Elections, County Government, Charlotte City Government, CMS Board of Education, Mecklenburg County Courts, and local media, giving participants an overview of how local government works. "Thanks to the grants we have secured," notes Suzanne, "we offer the sessions for free. We have also found that after taking the class, people are interested in running for local office."

The League also offers Vote411, an online resource committed to providing voters the information they need to successfully participate in elections. Information on candidates and their positions on issues is also available on the website. "We stay very busy finding assistance and resources for voters," says Suzanne. "Currently, we are getting ready to educate people about the changes in N.C. laws for absentee ballots and voter ID."

One area Suzanne is most proud of is her participation as liaison last year between N.C. league chapters and The Carter Center, a global entity working to ensure the integrity of elections around the world. The Carter Center funded a series of town halls held in each of N.C.'s 14 congressional districts to educate citizens about the electoral process drawing on the knowledge of cybersecurity experts, election officials, and election law attorneys from both political parties. "It was a very rewarding experience," says Suzanne.

Margaret first joined the League in the 1970s and then took a 35-year hiatus while working and raising a family. After retirement, Margaret relocated to Charlotte and immediately re-joined the League. "It fits in with a lot of what I believe in," says Margaret. "I like knowing what is going on politically. I want to do more than just vote and the league has a lot of different possibilities for volunteering. I also like that the League is nonpartisan and studies the issues before taking a position on them."

Margaret has been membership chair and roster-keeper for seven years. At this year's biennial convention, she won the state award for Outstanding League Board Member. "These awards are very prestigious," says Suzanne. "We are so proud that one of our members is a recipient of this award. And of course, she earned it!"

When new members join, Margaret invites them to coffee as an orientation to the League. "Every chapter has its peculiarities based on its local community," says Margaret. "This allows new members to test the waters before they decide where they will fit best."

Margaret also enjoys working with the League to register new citizens to vote. "It is such an uplifting time for everyone," says Margaret. "When you realize what our new citizens have been through to become citizens, it makes you grateful to be a part of their journey to be voters and to know that democracy has become stronger. Registering new citizens is the best thing I have done with the League."

She is also involved with the League's Education Action Team. "Public schools are a hot topic in N.C.," says Margaret. "I have two grandchildren in public school so I have a vested interest in supporting our local schools and doing the best we can for them." A professional librarian, Margaret volunteers in a local school's media center and has been a reading buddy for five years.

And although it is called the League of Women Voters, men are involved with the League as well. "There was some discussion of changing the name," says Margaret, "but the League decided against it. However, men are welcomed and we have a few serving in leadership positions in our local League. We are very happy to have them."

"We welcome all new members," says Suzanne. "Despite varied interests, we offer something for everyone."

"I like that the local League is so diverse," says Margaret. "We have members from all over the country who now live in Charlotte. The League is big enough for everyone. But what I like best is that the League gives me something to think about. And it provides a way for me to make friends and have fun."
