

Still No State Budget: Consequences



We are now over a month into the new fiscal year and there is still no budget in place. The legislature has not been in session in 6 weeks. **The lack of a budget is concerning for a myriad of reasons**, including the way it exacerbates issues created under previous budgets. For example, the Secretary of State's Office handles a wide range of paperwork, including new business filings, which are up 70% since the pandemic. With the increase in business, the S.O.S. Office has had no appreciable staff increase. Additionally, turnover rates in state agencies continue to increase as the rate of new applications decreases. Learn more [here](#).

It's not just the Secretary of State's office. **There are significant, persistent staffing shortages at all state agencies and public school systems due to low pay and inability to recruit and retain workers.** If you've been to a DMV office or tried to make an appointment lately, you know how short-staffed they are and how long the waits are. There are **significant bus driver shortages** at several school districts, including Charlotte Mecklenburg Schools.

In addition to the employment shortages in government departments, **Medicaid expansion is postponed as a result of the delayed budget.** Though the expansion of Medicaid has bipartisan, near-unanimous support this session, expansion cannot go into effect until there is a state budget in place. In the meantime, more rural hospitals are closing and people are losing coverage and falling sick. Learn more about what Medicaid Expansion, and its delay, means for North Carolinians [here](#).

The Senate has been called back for a one-day session next week, but we are told the budget will not be ready for consideration by then. It may be September or later before NCGA leaders reach agreement.

Voter ID: What You Need To Know

Beginning this year, voters will be asked to show photo ID at the polls. Absentee voters must include a copy of their ID with their mail-in ballot.

The first elections that will be conducted under the new rules will be the 2023 municipal elections:

November 7: general election for the Cities and Towns in Mecklenburg County and CMS Board At-Large
September 12: primary election for the City of Charlotte

Acceptable Forms of Identification

North Carolina driver's license (with current address and exact name match)

Approved Student ID (varies by school)

Out of State Driver's license or non-driver ID (only if you registered in NC within 90 days of the election)

U.S. Passport

State voter photo ID issued by a county board of elections or NCDMV

Approved state employee, local government, or school employee ID

15 School Districts in North Carolina Defy State Law, Starting School Year Earlier than Legally Allowed



Though North Carolina law forbids most traditional public schools to start the school year before the last week of August, an increasing number are defying the law and starting sooner. This year, the official start date is August 28, which CMS is honoring. It has long been a goal of CMS to start sooner, to allow students to take mid-year exams before winter break and to allow high school students to attend community college courses. I have filed bills seeking that calendar flexibility, but those requests have been denied. CMS did not want to risk getting sued, as happened in Union County. Despite the state law, Rowan and Stanly counties started August 9; Clay and Surry counties started August 10; Avery, Henderson, Iredell, Lee, Polk and Rutherford counties start on August 14; and Cleveland, Gaston, Jackson, Lincoln and Yadkin counties start on August 16. Public Charter schools are not restrained by the state law and may start earlier. Most local charter schools start this week or next. Read more [here](#).

Public Health Update



North Carolina is experiencing a summer surge in COVID-19 cases. Hospital visits, hospitalizations due to COVID-19 and evidence of the virus in wastewater have been increasing since early July.

Stay home & take an at-home test if you feel unwell. Those who last had a vaccine or COVID-19 5+ months ago may want to stay away from crowds indoors and wash their hands with soap and water more than usual.

Lake Norman Charter Boat and Boat Rental Regulations Revisions



The [Lake Norman Marine Commission](#) (LNMC) will host its August meeting on Monday, August 14, beginning at 7:00 PM. This meeting will be held at the Charles Mack Citizen Center (15 N Main St, Mooresville, NC 28115), and will discuss changes made to boat rental and charter boat regulations, effective in January 2024. Anyone wishing to make a public comment should sign up prior to the start of the meeting. All comments are limited to 3 minutes.

The new boat rental regulations are aimed at increasing the safety of those who rent boats on Lake Norman. They will require inspections and permits for each boat, liability insurance, and renter training requirements. The new charter boat regulations are aimed at increasing the safety of those who are chartering boats or paying fees for various boat cruises and other advertised activities on Lake Norman. The new regulations will require all charter boats to have a permit issued by the Commission, proper levels of insurance, and to have a Captain with a valid U.S. Coast Guard Master's license. 

Bizarre Local News



The National Weather Service has confirmed that a second tornado formed during Monday's record-breaking severe weather outbreak. The first tornado struck portions of Catawba, Iredell, and Rowan counties. The second tornado (an EF0 tornado with 85 mph winds) touched down in Huntersville (its path shown above).

At least two injuries were reported Tuesday in the greater Charlotte area as a result of the storms, which produced more damage reports than any other day in the western Carolinas in the past two decades. Read more [here](#).

COVID-19 Test Updates



COVID TESTS are approved for use after expiration date. The FDA granted another three-month shelf-life extension for the iHealth COVID-19 Antigen Rapid Test, which extended the shelf-life of all iHealth tests from 6 months to 15 months. Please use the tool at the link below to check the most updated expiration date of your kit. FDA for shelf-life extensions are issued every three months based on stability studies, and the new shelf-lives for our tests will apply to tests already produced as well as future production. 
