Updates on Noteworthy Votes



Below are a few noteworthy bills I voted on over the past two weeks. You can find a full list of bills I have voted on this session [here](#).

Key bills on which I voted YES:

- **HB323, Retain Adult Developmental Vocational Rehabilitation Programs.** Prohibits the Department of Health and Human Services from reducing the number of Adult Developmental and Vocational Programs and Community Rehabilitation Programs or the number of individuals in those programs without consulting stakeholders and or appropriately reviewing current services. These programs are designed to help individuals to live and work as independently as possible, and offer a wide range of employment and support services.*
- **HB422, Unfair Real Estate Agreements Act.** Prohibits companies from using oppressive and excessively long-term agreements that undermine a person's ownership of their home and provides remedies for owners who are inconvenienced or damaged by the recording of unfair real estate service agreements. Key bills on which I voted NO:

- **SB9, Local Omnibus Changes.** This bill originally was a local bill dealing with elections in the town of Apex, but was amended to impact police and fire departments in Winston-Salem and the school board in Greensboro in ways that interfere with local government. Read more [here](#).
- **SB176, Consumers in Crisis Protection Act.** Allows loan companies to advance up to \$400,000 to a consumer pursuing a legal claim. The consumer would then pay the loan company back, with interest, out of any net proceeds recovered in the legal claim. When this bill was heard in the Senate Judiciary Committee, we raised concerns about its interference with the attorney-client relationship and its potential to get people into unfair debt.
- **SB512, Greater Accountability for Boards/Commissions.** Consolidates more power in the partisan-controlled NCGA and away from the executive branch. Replaces the entire state Board of Transportation and shifts appointment powers. Reduces or reallocates gubernatorial appointments to eight governing boards, including the Commission for Public Health and the Environmental Management Commission, which sets a number of business regulations. This bill goes against the precedent set by two state Supreme Court decisions over the past decade and is likely unconstitutional. Read more [here](#).
- **SB747, Elections Laws Changes.** Repeals the 3-day grace period for absentee ballots postmarked by Election Day (so ballots arriving after Election Day will not be counted), prohibits state or county boards of elections from accepting private donations for election administration, purges individuals from voter rolls based on jury disqualification, encourages poll observers to listen to conversations between voters and election workers, and more. [Though some of the harmful and vague sections of this bill have been repealed or amended](#), I do not support this bill. It will discourage certain voters from casting ballots and will cause valid ballots to be discarded instead of counted. In addition to the significant modifications to the voting process, the NCGA is not funding the boards of elections to ensure voters are informed of the new requirements or that ballots and polling locations will be ready and accurate in time for upcoming elections. Vetoes and Overrides



Over the past two weeks, Governor Cooper vetoed the following bills. So far, the NCGA has overridden six:

- **SB49, Parent's Bill of Rights.** I voted to sustain the Governor's veto. This is not about parental rights; it's an injection of culture wars into our classrooms. SB49 burdens school staff with requests and objections without penalty for abusive and frivolous behavior, undermines our ability to gather anonymous data about student health and well-being, disallows any books or other curriculum that discusses LGBTQ families in K-4, and forbids school staff from providing confidential advice or assistance to students. It targets some of the most vulnerable members of our communities and undermines public education. While debating the override on the floor, I spoke about what students and parents actually want the NCGA to address, such as school shootings and teacher, staff, and bus driver shortages. - **HB219, Charter School Omnibus.** I voted to sustain the Governor's veto. This bill allows unfair pre-lottery priority admissions to charters for children who attend certain preschools, prevents the Charter Review Board from considering the impacts of charter approvals and renewals on local public schools, removes restrictions on growth for low-performing charters, and allows counties to appropriate property taxes to fund charter school capital needs. The State Board of Education should continue to oversee the enrollment of charter schools to assure success and accountability and North Carolina should continue to cap the enrollment of low-performing charter schools. - **HB488, Code Council Reorganization and Various Code Amendments.** I voted to sustain the Governor's veto. This bill undermines our energy efficiency and safety goals because it freezes residential building code standards at an already outdated level. It also splits the Building Code Council into two committees, commercial and residential, limits the governor's appointment power to the council, and will likely cause North Carolina to lose federal dollars under the FEMA program. Our state building standards are already outdated, so further delay is a mistake and will result in higher energy costs for new home buyers. The bill is supported by builders, contractors, and developers. The measure is opposed by local fire marshals, environmentalists, and consumer protection advocates. Read more [here](#).*
- **HB574, Fairness in Women's Sports Act.** This bill prevents transgender girls from participating in school sports from kindergarten through the collegiate level (private and public). I oppose this blanket ban because it's unfair and hurtful, and voted to sustain the veto. There are already procedures in place to determine which team is appropriate for transgender athletes, on a case-by-case basis, taking all facts into consideration. Additionally, there are only 2 transgender girls in North Carolina playing sports at the K-12 level, which further demonstrates that this bill is unnecessary. Republican governors in other states have vetoed similar bills because they hurt their states' reputation and economy, and because they needlessly target an extremely small number of already vulnerable children. - **HB618, Charter School Review Board.** I voted to sustain the Governor's veto. In North Carolina, it has always been the responsibility of the State Board of Education to supervise free public education, including charter schools. The new charter school board established by this bill will have conflicts of interest; they are people who run charters and are vocal advocates for charter schools. We need serious and unbiased oversight as provided by the NC Constitution. This bill is bad policy and unconstitutional. Education experts, not partisan politicians, should conduct oversight of charter schools. Read more [here](#).*
- **HB808, Gender Transition/Minors.** I voted to sustain the Governor's veto. This bill strips rights from the parents of transgender children and undermines the standards of care utilized by accredited medical organizations. Republican governors from other states have rejected similar bills, and courts in other states have ruled that similar bills violate the constitutional rights of doctors and discriminated against transgender people. I voted no on HB808 because it is discriminatory and based on faulty information. Ordering doctors to stop following approved medical protocols sets a troubling precedent and is dangerous for vulnerable youth. Read more [here](#).*

Senator Marcus in the Community



Last week I was able to volunteer at two Back to School community events. At Smithville Park, I helped [Unity in Community](#) offer non-partisan voter registration. It was exciting to pre-register two teenagers, help two people update their address, and register an 18 year old new voter. The crowd was full of friendly people, many of whom are from other countries including Japan, Afghanistan, El Salvador, Mexico and Venezuela. Immigration makes our community more interesting!



Last Friday, I discussed gender violence and abortion access with a delegation from Kyrgyzstan (previously part of the USSR) and members of the [North Carolina Reproductive Access Network](#). The Kyrgyzstan delegation was hosted by the US Department of State's Bureau of Educational and Cultural Affairs as part of its International Visitor Leadership Program, which addresses global issues through diplomatic engagement. We met at the [International House](#) in Charlotte.

The delegation was interested to learn about the impact of the *Dobbs* decision and the recent passage of [Senate Bill 20](#). We discussed how abortion restrictions in their country and in the US are a form of control and violence against women. It was a memorable opportunity to speak with people from the other side of the world and was memorable as the first time my words were interpreted into Russian and I was provided with an earpiece to listen to the delegate's remarks translated into English.



Last week, I attended the [Historic Hoskins Coalition Group](#)'s neighborhood meeting where they highlighted their partnership with [West Side Community Land and Trust](#) (WSCLT) and the recent purchase of 29 homes in the Historic Hoskins Community and 3 in the Freedom Drive area.

WSCLT's Executive Director shared their journey to acquire the homes, saving them from poor management and likely gentrification. The homes require significant updates to make them habitable. WSCLT has a plan to find alternative housing for the families while the homes are rebuilt/improved and families will have an option to return as homeowners. The homes will remain affordable in perpetuity.



The Charlotte Pride Parade felt especially important this year, given the discriminatory laws enacted last week in our state. The crowds were huge, showing so much love and kindness. I walked the route with several friends. Were you there?

Eliminate the Digital Divide's Laptop Giveaway Tomorrow



Last night, I attended Eliminate the Digital Divide (E2D)'s 10 year anniversary celebration, where founder Pat Millen announced that **E2D will be giving away 1,000 laptops for free at tomorrow's distribution event.** The event will be held on Saturday, August 26, from 9:00am-12:00pm at ImaginOn Library (300 E. 7th St). Parking is at the 7th St Parking Garage and will be free as well because E2D is validating parking!

E2D laptops are intended for families without sufficient access to technology and there is a maximum of 2 laptops per family. If you or a family member needs a laptop, be sure to get there early. This event is first come, first served.

The N.C. Department of Transportation is accepting public input through August 31 on what you would like to see in NCDOT's draft 10-year transportation plan for 2026-2035. The State Transportation Improvement Program (STIP) is updated every two years to ensure that NCDOT responds to transportation needs throughout the state. **So let them know what SD41 needs - whether big projects or small. Project priorities can be as large-scale as an interstate improvement or as small as a new turn lane or intersection improvement.** Priorities can be for any type of transportation.



HOMES Program and Mecklenburg County Homeowners



Helping Out Mecklenburg’s Homeowners with Economic Support (HOMES) is a county-created seasonal program designed to help Mecklenburg County residents reduce the cost of annual home ownership. HOMES offers qualifying homeowners an economic assistance grant of up to \$660. There is no age requirement to participate in the program, and the home does not have to be paid off. **The application period runs from July 1 to November 17, 2023.** Applications will be processed on a first-come, first-served basis until funds are exhausted.

Mecklenburg County homeowners who qualify for a HOMES grant are those who have lived in their home for at least the last three years and it is their primary residence, have no more than one delinquent tax bill in the last three years, and meet a qualifying total household income level. Applicants may pick up paper applications at the Department of Community Resources or the County Assessor’s Office, both at 3205 Freedom Drive in Charlotte, or request by phone at 980-314-4663. COVID TESTS are approved for use after expiration date. The FDA granted another three-month shelf-life extension for the iHealth COVID-19 Antigen Rapid Test, which extended the shelf-life of all iHealth tests from 6 months to 15 months. Please use the tool at the link below to check the most updated expiration date of your kit. FDA for shelf-life extensions are issued every three months based on stability studies, and the new shelf-lives for our tests will apply to tests already produced as well as future production. 
