January 8: First Mecklenburg Delegation Listening Session of 2024



On **Monday, January 8th**, members of the Mecklenburg delegation to the NC Senate and NC House will host a **listening session** in the Cornelius Town Hall Community Room (21445 Catawba Ave, Cornelius, NC 28031). This is your opportunity to tell us about the issues you would like us to work on in the 2024 Short Session and give us feedback on the work we've done to date. The listening session will begin at 6:30 PM, and I encourage everyone to attend, whether you live in SD41 or in the vicinity.

2023 Legislative Session Is Over



The NCGA ended our long session in October, following passage of the budget and the completion of redistricting. As a result, there have been no committee meetings or votes over the last two weeks. I'll keep you posted about any special sessions that may arise.

House Select Hearing on Auto Insurance



Last week, the North Carolina House of Representatives held a Select Committee hearing on auto insurance oversight and reform. North Carolina's auto insurance system includes what's known as a Reinsurance Facility to cover people with poor driving records, which is subsidized by fees that all drivers pay on their insurance policies. A [report commissioned by the legislature](#) found that roughly a quarter of insurance policies end up in the Reinsurance Facility, which it says is far higher than other states. The hearing included testimony from Insurance Commissioner Mike Causey, who argued that the Reinsurance Facility is a necessary program. Colonial Pipeline Reporting Update



According to a summary statement for the North Carolina Department of Environmental Quality submitted by Colonial Pipeline earlier this month, the monitoring systems put in place after the August 2020 fuel spill have recorded the following data:


- **System status:** Both systems are currently online and operating as expected.
- **Recovery:** The in-situ recovery volume from the installed well network on November 29, 2023, was **1,445,863 gallons of product** and **16,828,836 gallons of petroleum contact water**. The total gallons of product recovered, including that recovered from the well network, soil excavation, soil vapor, and emergency response activities, is **1,772,112 gallons**.
- **Benzene monitoring** at all site-wide and frack tank locations have had no detections.
- Colonial Pipeline plans to continue product recovery and optimization of pump depths in recovery wells, as well as benzene and ambient noise monitoring. Petroleum contact water and water supply watershed sampling will continue to occur on a weekly basis, and sitewide groundwater sampling on a monthly basis. The company also plans to expand the air sparge system on the southeast of the work area, and drilling for that project began earlier this month.

Golden Leaf Grant to Camino Community Development Corporation



The Golden LEAF Board of Directors voted to award \$169,850 to [Camino Community Development Corporation](#), an existing food bank partner agency in Mecklenburg County, for building renovation and to purchase equipment and a box truck to enable the organization to pick up, store, and distribute more food. The award was funded by the recent state appropriation to Golden LEAF for the Food Distribution Assistance Program. This program is funded by federal State Fiscal Recovery Funds through the North Carolina Department of Agriculture & Consumer Services.

Mecklenburg County Storm Water Services Flood Control and Restoration Project: Barlowe Road



Mecklenburg County Storm Water Services will conduct a flood control and restoration project in SD41 stretching 630 feet along County-owned property and a privately-owned residence at 606 Dewolfe St. The project will consist of removing a section of the bridge and road on Barlowe, adding wetlands, and restoring nearby Stewart Creek to reduce sediment loss. The work will help reduce the risks of flooding and improve water quality in the area. Mecklenburg has been awarded a grant of \$150,000 from the North Carolina Land and Water Fund Flood Risk Reduction Grant Cycle and \$500,000 from the North Carolina Land and Wildlife Fund to accomplish this project. CleanAIRE NC Awarded Grant to Improve Air Quality in North Mecklenburg Communities



The U.S. Environmental Protection Agency has awarded [CleanAIRE NC](#) funding to expand community air monitoring across four underserved communities in north Mecklenburg County in SD41: Huntington Green (Huntersville, NC); Pottstown (Huntersville, NC); Smithville (Cornelius, NC); and West Davidson (Davidson, NC). These areas experience higher pollution exposures than the more affluent neighborhoods surrounding them, resulting in vastly different experiences and health outcomes. The project targets longstanding health and environmental injustices caused by air pollution. CleanAIRE NC will work with community partners to distribute robust systems that capture local air quality data. Learn more [here](#).


