Happy 104 Birthday, Dear LWV!

Wednesday, February 14 is Valentine's Day and also the League of Women Voters' 104th birthday! We celebrate the birthday of an organization which stemmed from the suffrage movement as a "mighty political experiment" to assist 20 million women with their newly won voting rights. Over the ensuing century, the League has progressed into a powerful and respected nonpartisan organization with more than 700 state and local chapters influencing public policy and promoting informed civic involvement.



Founded by Carrie Chapman Catt in 1920, the League was most recently led by our dearly departed 20th president Deborah Ann Turner. Dr. Turner's passing was a shock to us all and she will be greatly missed. "She was a tireless advocate for voting rights and women's rights," said Voter Service Chair Regan Aduddell. "As we move forward, I keep thinking of something she would say at the end of her speeches: 'we need to keep on keeping on'. And in her memory, that is what we at the League will do—reach out and engage voters in our community."

In that spirit, the LWVCM is making its final push for the primary. Next Friday, February 9 is the last day to register voters. Regan and her team is working across the county from college campuses to Crisis Assistance, from Creative Mornings to Sarah Stevenson Tuesday Forum. Outreach is centered around registration and information about the new [photo ID requirements](#). Volunteers may learn about the new registration form by [watching the video](#) prepared by state. LWVCM Partners with Friendship Missionary Baptist on Nonpartisan Candidate Forums

Our League chapter will again partner with FMBC's Social Justice Ministry to put on nonpartisan candidate forums ahead of the March 5 Primary. Our own Suzanne Elsberry, President of LWV Charlotte Mecklenburg will moderate the first forum on February 20 at 6:30 PM which will include candidates for Governor, Lieutenant Governor, Attorney General and Superintendent of Public Instruction.

Other forums will take place on Feb. 22 (US Congress, NC Senate and House, and Mecklenburg) and Feb. 27 (NC Supreme Court, NC Court of Appeals, Secretary of State, Treasurer, Auditor, and Commissioners of Agriculture, Insurance and Labor).

League members will have the opportunity to volunteer for voter registration tables and other roles as the forums approach. A dry run is scheduled for Thursday, Feb. 15 at 6 PM at Friendship Missionary Baptist Church (3400 Beatties Ford Road, Charlotte) where all forums will be held.

LWVNC Tax Policy Review Team Update

Part two of the LWVNC Tax Policy Review Committee presentations leading to a refined tax policy position for advocacy will take place Tuesday, February 20 at 7 PM (Zoom). LWVNC member Dr. Kenneth Klase of Greensboro will talk about the types of state and local taxation, pros/cons and issues of equity.

LWVCM to Join Day of Action for Education Rights

Members of the LWVCM Education Action Committee will travel to Raleigh on February 22 to join with our longtime advocacy partners Every Child NC for a Day of Action for Education Rights. That is the day that the North Carolina Supreme Court will (re)hear oral arguments on the Leandro school funding case. To be clear, there has been no material change to the facts of the case. The court's move to reopen a settled case is most unprecedented.


Addressing the UU Social Justice Action Hour, Sarah Montgomery of [Every Child NC](#) Coalition and a Senior Education Policy Advocate at the [NC Justice Center](#), briefed attendees about the current state of the Leandro case.

"Leandro was designed to disrupt the inequities baked into a business as usual public education funding model. It is intended to lift up those students and communities who have been historically underserved."

Montgomery and her team see two likely scenarios for the case: 1) an uneventful hearing with the justices kicking the case back to the lower courts, or 2) Leandro gets overturned, calling nearly 30 years of established law into question. She was quick to say that, "No matter the outcome, the court cannot take away the constitutional right of a *sound basic education* for every child in North Carolina."

David Hinojosa from [Lawyers' Committee for Civil Rights](#) in DC—whose expertise in systemic racial justice work in public education makes him a perfect advisor to Every Child NC—indicated that the November 2022 ruling that ordered the NC General Assembly to immediately transfer funds owed was one of the strongest rulings he had seen. The victory has been in peril every since. In fact, Every Child NC sees the recent legislation that expands the use of vouchers as a cynical response to the Leandro ruling. "Voucher expansion is the other side of the Leandro coin," Montgomery stated.

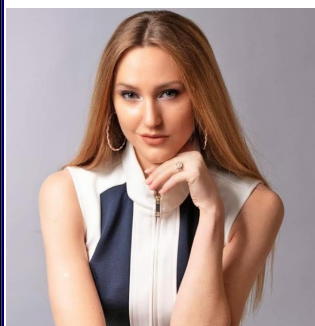

LWVCM President's Perspective

Recollections of Dr. Deborah Ann Turner (1950-2024)



I first saw Dr. Turner as she chaired the 55th LWVUS Convention in Denver, Colorado in June, 2022. The convention had barely begun when we received the devastating news of the SCOTUS decision overturning Roe v Wade. That evening, Dr. Turner led the assembly in chanting and singing and bearing signs in a protest march to the Capitol. I met her as we gathered under the gold dome and subsequently identified her to the surrounding news reporters from whom she graciously took questions.

Months later, I attended the 75th anniversary celebration of the Orange-Durham-Chatham chapter in Chapel Hill at which Dr. Turner was the keynote speaker. She charmed and delighted the audience by opening, as she had done at the convention, with a joyful, inspirational song which we came to recognize as her signature for every speaking event.

I was fortunate to have been seated across from her at the dinner following, and along with the other guests, was treated to her many personal stories and observations.

LWVCM hosted the North Carolina State League convention in May and once again, we were honored with her visit to our state. Attendees found her, as had I, down-to-earth, friendly, warm and always interested in the voices of others. Despite our National President being so very approachable, warm and responsive, one inevitably experienced the feeling of being in the presence of greatness. It was a supreme honor for me to have known her. Due to her frequent visits to our state, many North Carolina Leaguers have remarked upon our special feelings of affinity and connection with Dr. Turner.

Recalling Dr. Turner, the word "JOY" registers in my mind. Although dealing with very serious and profound issues, she approached her work with a joyfulness that was delightful and contagious. Doubtless, her legacy of "Keep on Keeping on" will remain with us through the next 104 years of the League as we empower voters and defend democracy coupled with a sense of determination and JOY inspired by this extraordinary woman and leader!

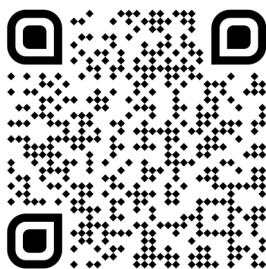
League In Action (LIA) Is Here

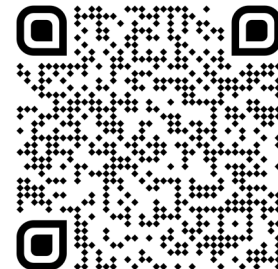

Eye on the Environment: The Problem with Plastics

Plastics are cheap to produce, convenient to use, and comprise multi-billion dollar industries. Climb the earth's highest mountains or sink to the deepest ocean trenches and you will find plastic, in the form of waste. Plastic waste is ubiquitous in our oceans, our waterways, on our streets, and our landfills. Scientists have detected plastic particles in human tissue, brains, blood, heart muscle and pregnant women's breast milk and placenta.

A report published in the [Annals of Global Health](#), conservatively estimated that Americans spent more than \$250 billion on health costs related to plastics in 2015.

Worldwide production of plastic has doubled in the past 20 years, and evidence is mounting that plastics are bad for our health, costing us money, and polluting the earth. What can be done?

According to *Beyond Plastics* President and former EPA Regional Administrator Judith Enck, "It will take changes at every level of our economy and civil life to stem the tide of plastic pollution, including grassroots advocacy, corporate pressure, legislation, and global cooperation." Enck testified at the Senate Committee on the Environment and Public Works' Subcommittee on Chemical Safety, Waste Management, Environmental Justice, and Regulatory Oversight in 2022. It was the first time such a hearing was convened to discuss the plastic pollution crisis.

What can we as individuals do? **Support Legislation** that reduces production of petrochemicals in food packaging, where chemicals migrate from packaging to food. Nearly half of all plastics manufactured today are single use items and packaging. Lawmakers must regulate the chemical content and toxicity of plastic. Citizens must demand plastic-free options.

Demand Producer responsibility. Stop the production. Plastic producers are filling demand for easy, cheap single use packaging. Only an estimated 8% of plastic waste is recycled. **Do an audit** of the plastics in your home. **Avoid single use plastics** such as straws, cutlery & plates. **Use your own shopping bag** & support plastic bag bans. **Buy cans** and cartons instead of single-use plastic bottles. **Carry** a reusable water bottle. **Wear clothing** made from natural fibers. **Recycle right.** (See [Meck County Recycling Rules.](#)) **Follow and support organizations** who advocate for an end to the plastic pollution crisis. An online search will produce many. Here are a few: [Beyond Plastics](#) is a grassroots advocacy and education organization. [Break Free From Plastic](#) is a global multi-organizational movement working to bring about systemic change by tackling plastic pollution across the whole value chain - from extraction to disposal - focusing on prevention rather than cure. [Plastic Oceans](#) advocates for global change with local actions and fosters sustainable communities through changes in consumer behavior, corporate practices, and public policy.

Board of County Commissioners Update

If you missed the public hearing and want your voice heard about the FY2025 Mecklenburg County budget, take a few minutes to participate in the commissioners' budget priority survey. The annual resident budget priority survey provides residents the opportunity to share their perspectives on the County's budget and investments. Responses are collected to support their decision-making during the budget development and priority setting process.

Four League members of the LWVCM Education Team spoke to the board at its January 17 public hearing about supporting teachers, emphasizing the need for competitive salaries to fill the hundreds of CMS vacancies and to retain them after they are hired. President Suzanne Elsberry, Sara Baysinger, Carol Gray-Adler and Jeanne Smith, co-chair gave powerful presentations about teachers' needs and obstacles. They emphasized that beginning teachers cannot afford a one-bedroom apartment in Charlotte on their current salary.

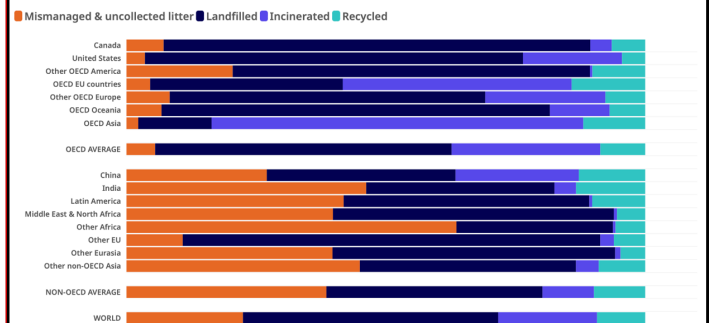
"And though our community cannot alleviate all the stress points that teachers feel, the one thing we can do is help validate their worth by providing them with adequate pay," Sara told the board.

The board met at the end of the month for its three-day retreat hearing updates on its priorities and investments as it starts preparing the 2025 budget.
