RALEIGH, N.C. — In a state where insurance premiums have skyrocketed due to Mike Causey's 16 total insurance rate hikes, North Carolinians are finally getting the full picture. While Causey and his campaign have never made it possible for North Carolinians to empirically examine his record and impact on their wallets, this information has finally been made easily accessible to the public by scouring Causey's consent decrees and rate agreements with the insurance companies' Rate Bureau.
